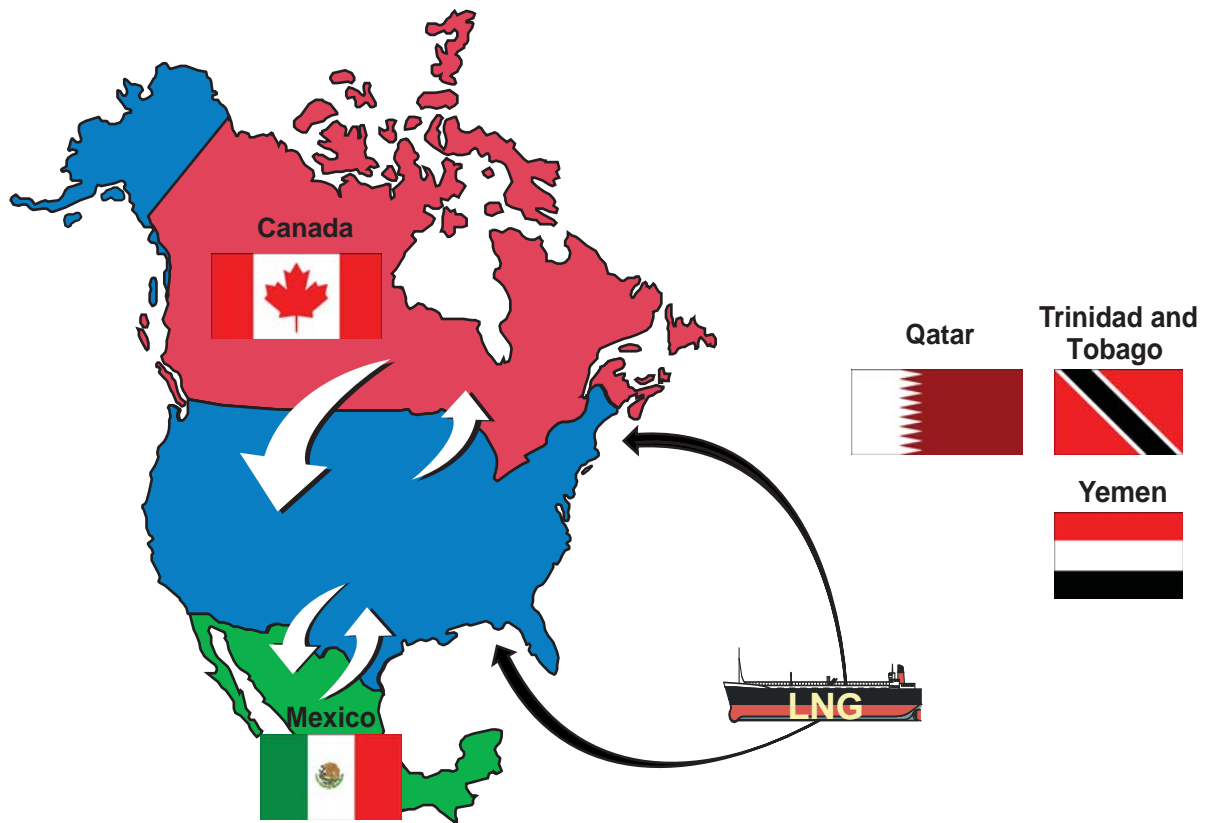

SUMMARY

The Office of Oil and Gas Global Security and Supply, Office of Natural Gas Regulatory Activities prepares quarterly reports showing natural gas import and export activity. Companies are required, as a condition of their authorizations, to file monthly reports. This Natural Gas Import and Export Report is for the first quarter of 2013 (January through March).

Sections 1 and 2 contain quarterly summary charts and tables. Section 3 contains the detailed transactions of all imports and exports. The data in Section 3 is organized by activity: long-term imports, long-term exports, short-term imports, and short-term exports. There is a table of contents for your convenience.

Please note that the import/export summary map formerly published on the reverse of the report's cover page has been replaced. A group of four maps is now the first sub-section of Section 1. The maps illustrate vessel-borne LNG imports and exports, as well as imports and exports from and to Canada and Mexico, by US region.

First Quarter 2013 Highlights

Imports totaled 783.6 Bcf and exports totaled 436.3 Bcf, resulting in net imports of 347.2 Bcf. As usual, most of the imports came from Canada, comprising 95.8 percent of total imports. LNG imports made up nearly all the remaining 4.2 percent of total imports. Imports from Mexico were negligible at only 0.057 Bcf for the quarter (less than 0.01 percent of total imports). As with imports, the majority of exports went to Canada, making up 63.2 percent of the total. Exports to Mexico comprised the remainder. There were no domestic LNG exports by vessel or re-exports of previously imported foreign-source LNG in the first quarter of 2013.

First Quarter 2013 vs. Fourth Quarter 2012 - Highlights

As illustrated in the following tables, total imports increased 3.5 percent compared to last quarter. This increase in imports was entirely due to a 4.8 percent increase in Canadian imports and despite a 20.0 percent decrease in LNG imports and an 18.1 percent decrease in Mexican imports. The average price for imports was up 8.0 percent overall. This was due to an 8.3 percent increase in the average price of Canadian imports and an 11.6 percent increase in the average price of LNG Imports. The average price of the very small volume of imports from Mexico fell 6.0 percent.

Total exports were down 1.0 percent from last quarter. The decrease was mostly due to the absence of any LNG exports by vessel or LNG re-exports. Mexican exports also fell by 1.1 percent while Canadian exports increased 2.7 percent. Pipeline export prices were up 4.2 percent compared to last quarter.

First Quarter 2013 vs. First Quarter 2012 – Highlights

Total imports were down 6.8 percent from the first quarter of 2012. Imports were down across the board compared to the first quarter of 2012, with Canadian imports decreasing 4.4 percent, Mexican imports decreasing by 42.4 percent and LNG imports decreasing by 39.9 percent. The average price increased 40.9 percent for pipeline imports and 57.0 percent for LNG imports.

Total exports were up by 8.6 percent. This increase was due to a 4.7 percent increase in Canadian exports and a 25.7 percent increase in Mexican exports. For this same period, pipeline export prices were up by 35.0 percent.

LNG Imports and Exports

LNG imports decreased 20.0 percent compared to last quarter and decreased by 39.9 percent compared to the first quarter of 2012. Twelve cargos of LNG were imported this quarter, compared to fourteen cargos last quarter and twenty-two full cargos and one partial cargo in the first quarter of 2012. LNG import prices were up 11.6 percent from last quarter and up 57.0 percent from the first quarter 2012. There were no LNG export cargos this quarter, compared to one last quarter and none in the first quarter of 2012. There were no LNG re-exports this quarter compared to three cargos last quarter and four cargos in the first quarter of 2012.

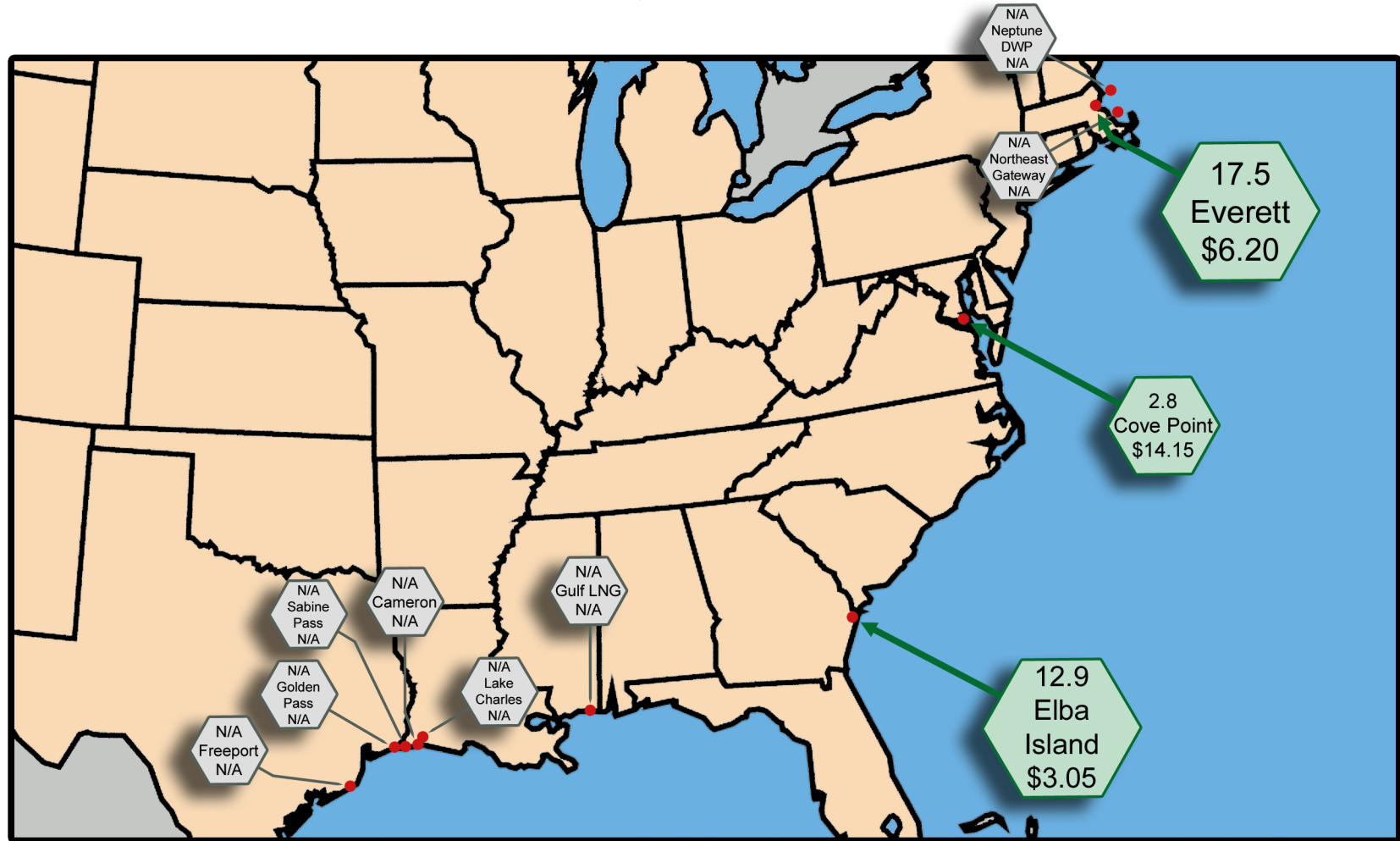

Maps of Imports & Exports by Point of Entry/Exit

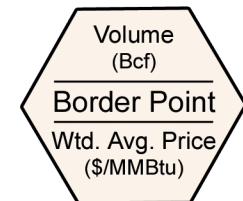

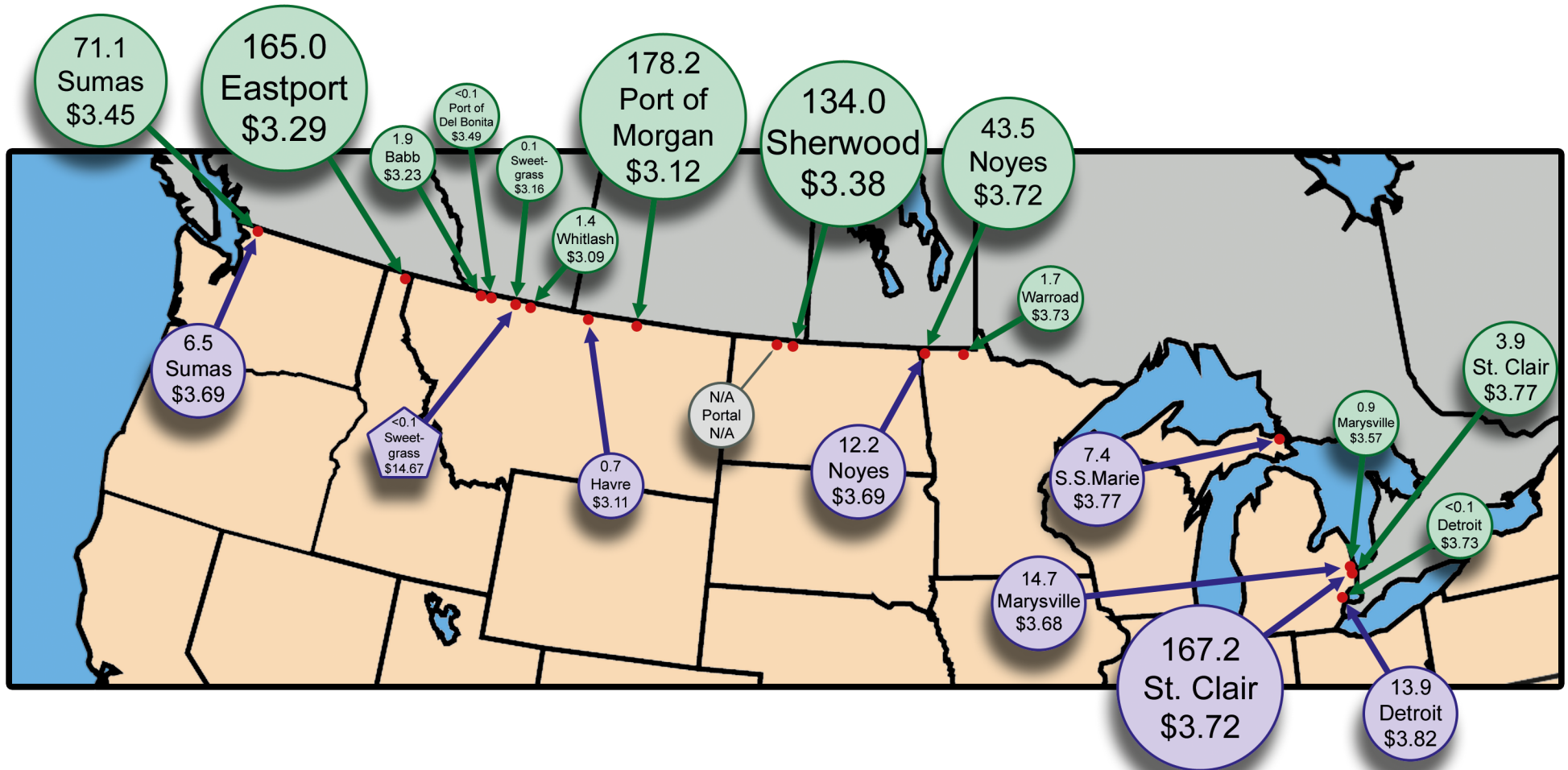

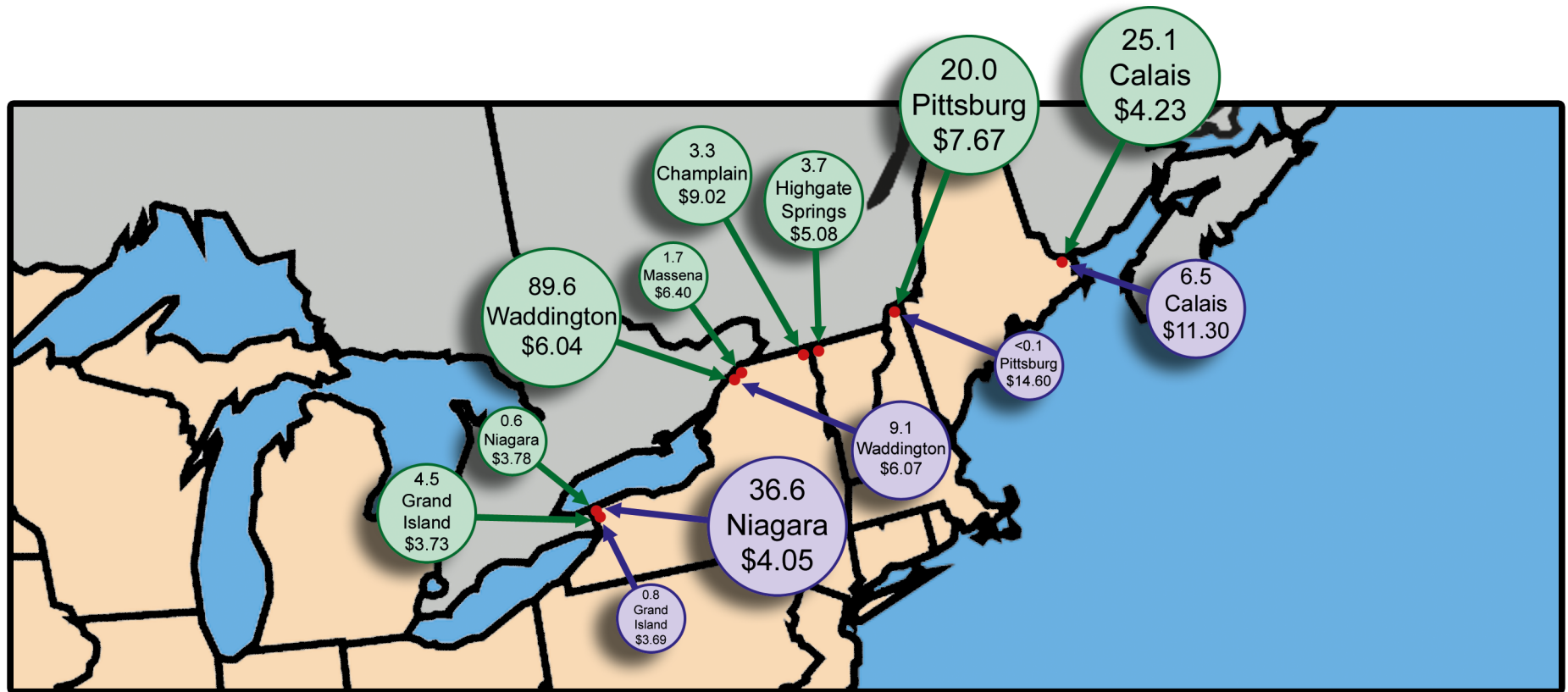

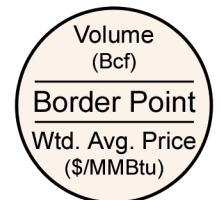
Natural Gas Imports & Exports by Border Point

 ● Pipeline Export

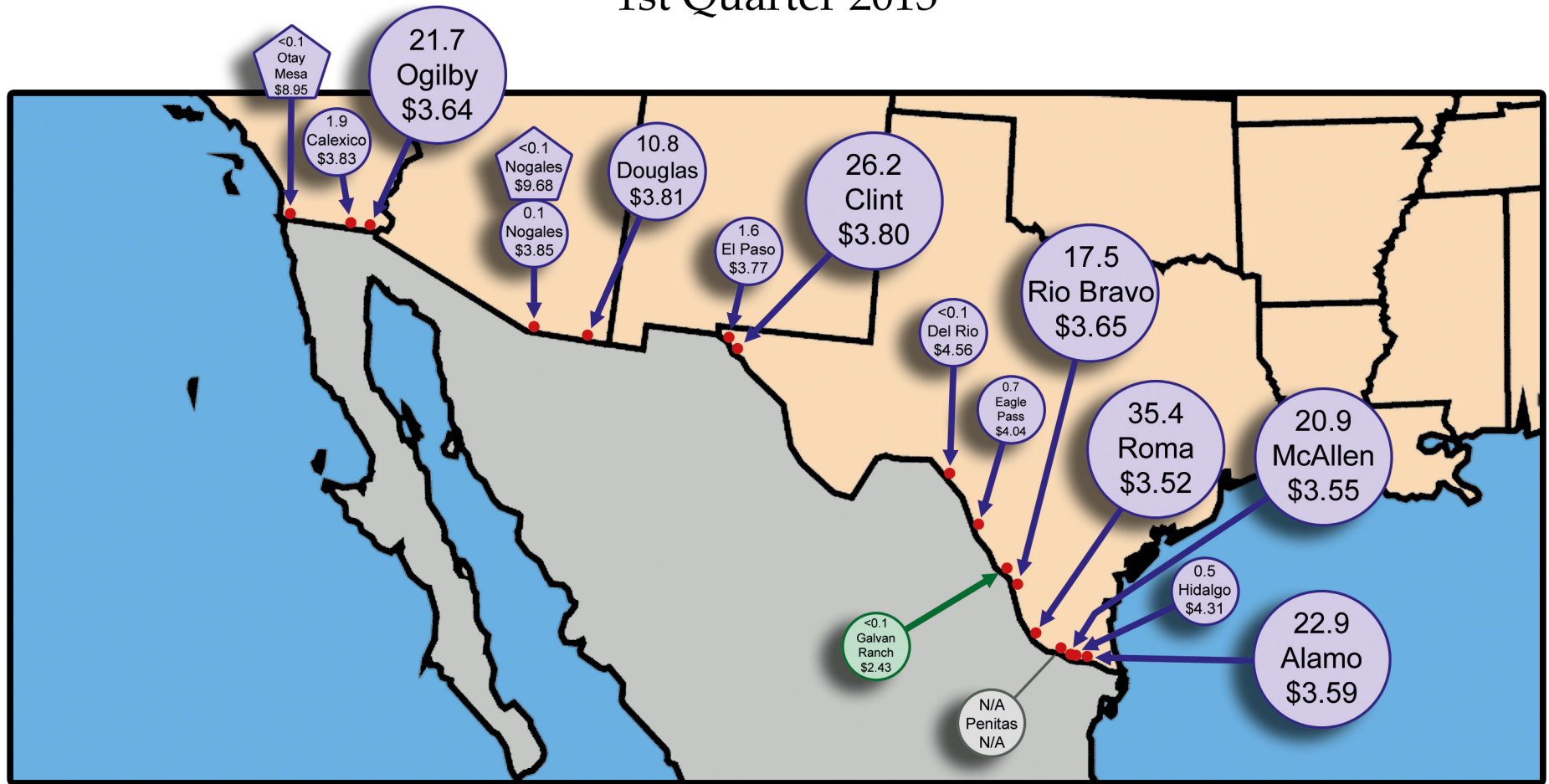

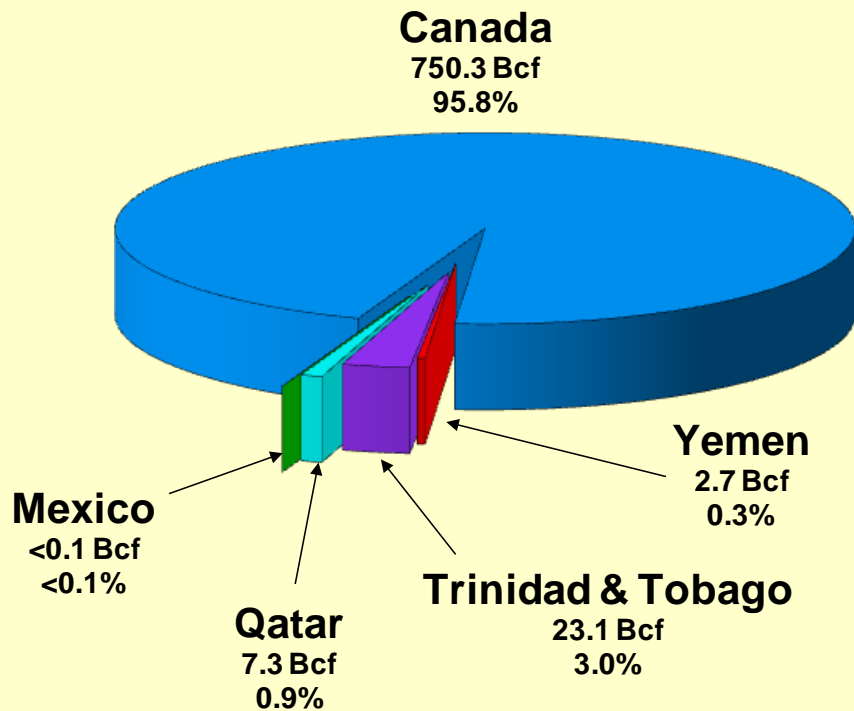

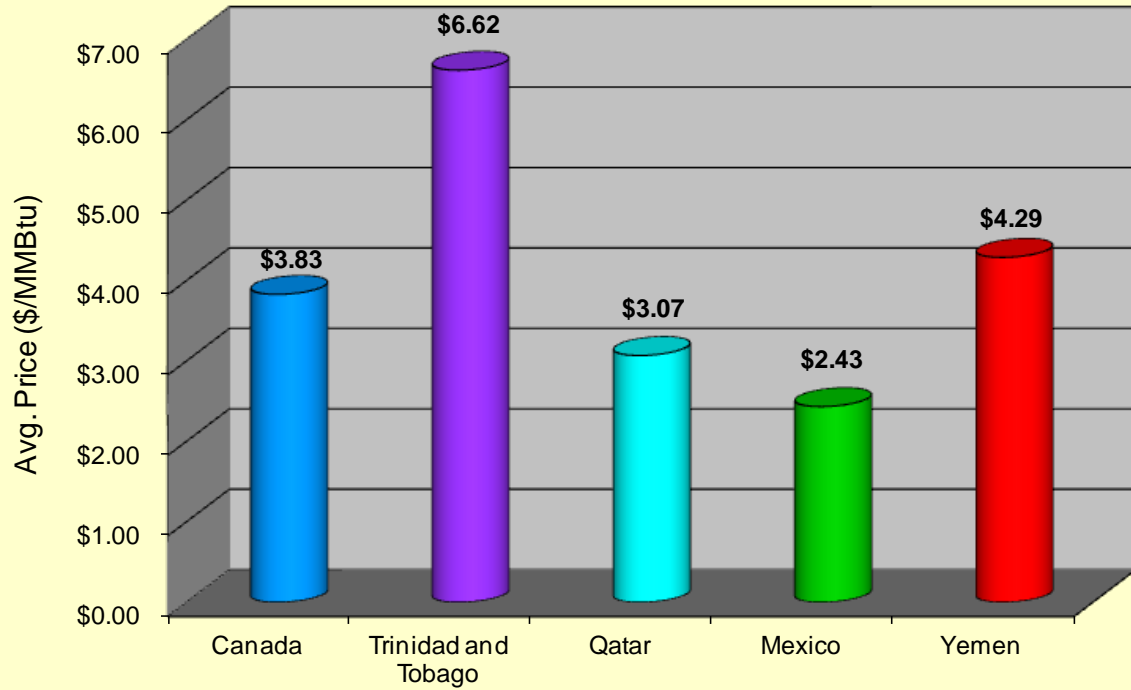
Natural Gas Imports, 1st Quarter 2013

- In the first quarter of 2013, the U.S. imported more than 780 Bcf of natural gas.
- A large majority of imports originated in Canada, continuing a long-term trend. Trinidad & Tobago was the next-largest supplier, providing 3.0% of imports.
- Only three other countries supplied the U.S. with gas during the quarter. LNG was imported from both Qatar and Yemen. Only a tiny amount of natural gas was imported from Mexico (57,013 Mcf).

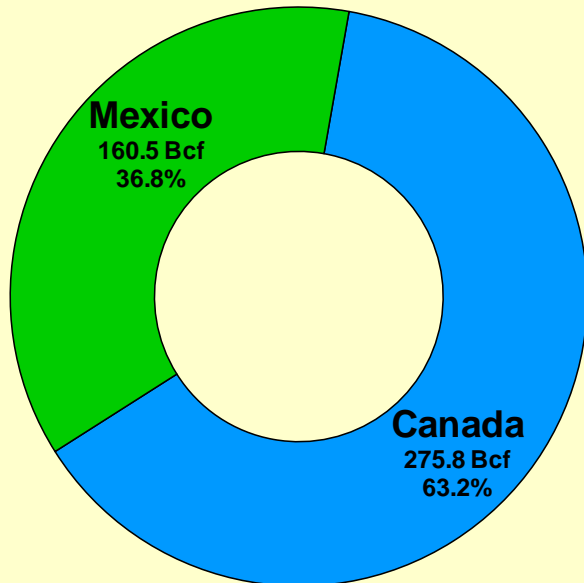
Avg. Import Prices, 1Q 2013

Domestic Natural Gas Exports, 1Q 2013

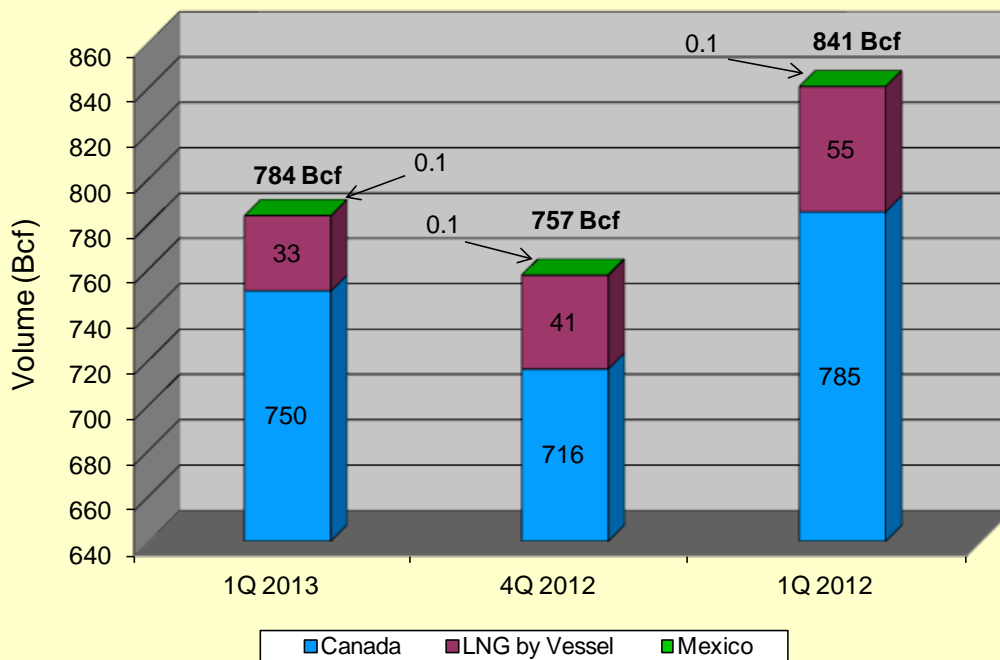
Total Domestic Natural Gas Exports - 436.3 Bcf

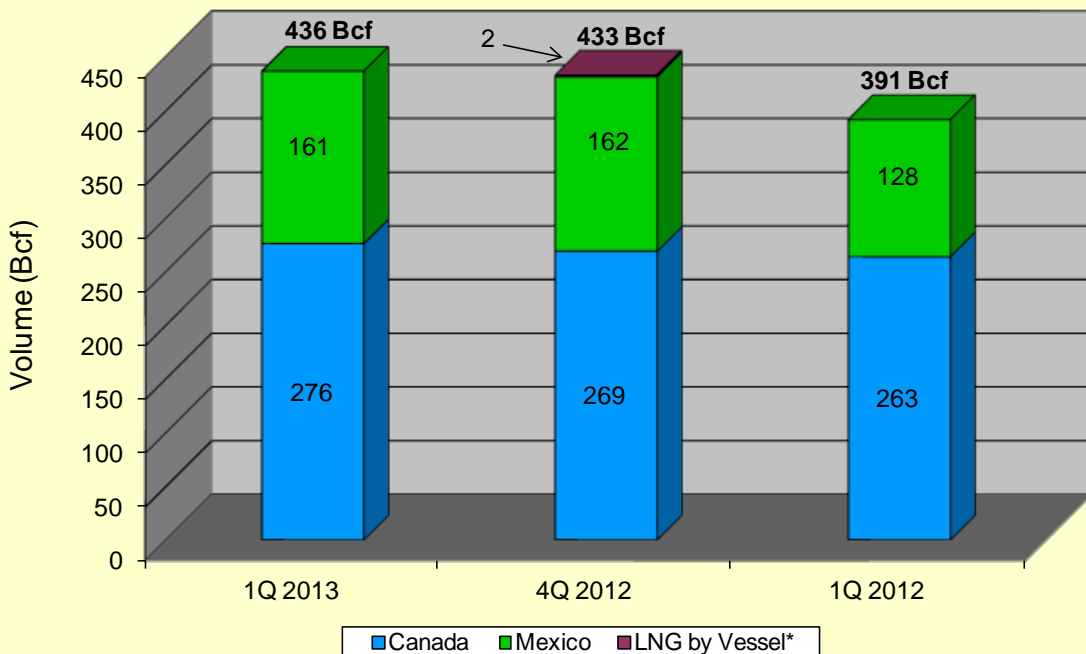
- Almost two-thirds of U.S. exports of domestically-produced natural gas during the first quarter were sent to Canada.

- The total volume of first quarter imports was higher than last quarter but lower than the first quarter of last year.

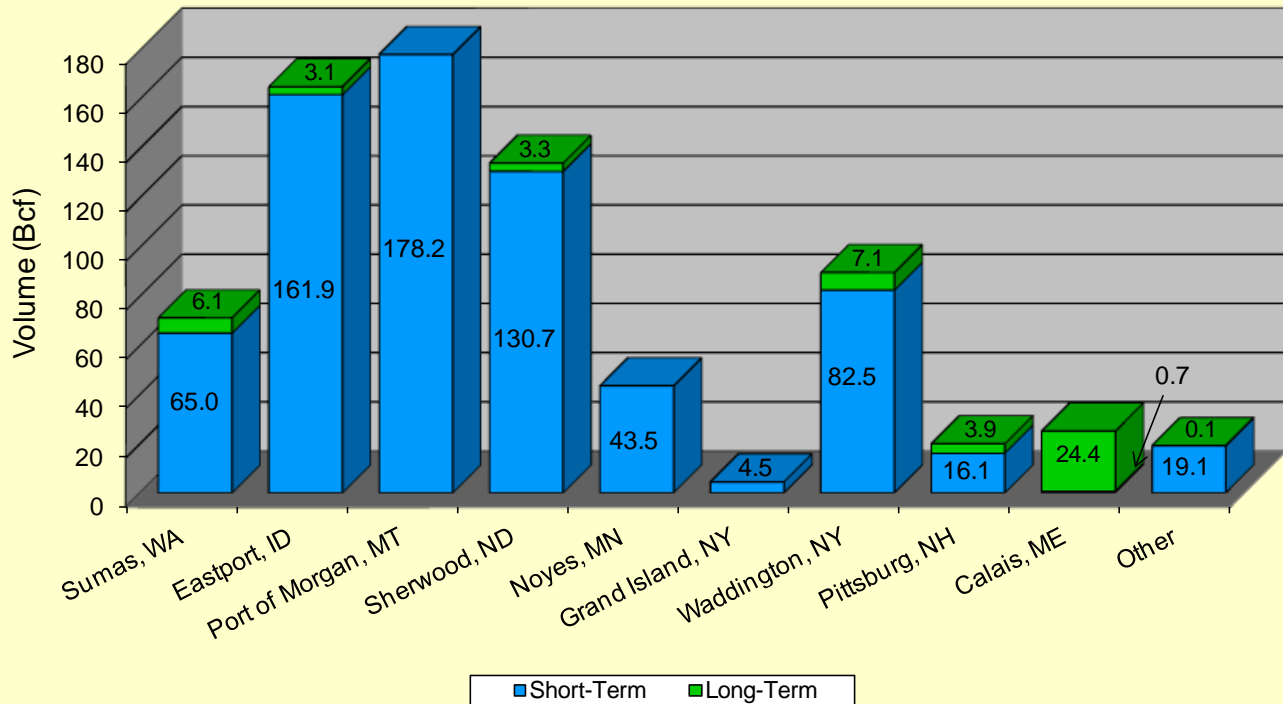
Comparison of 1Q Exports with Previous Quarters

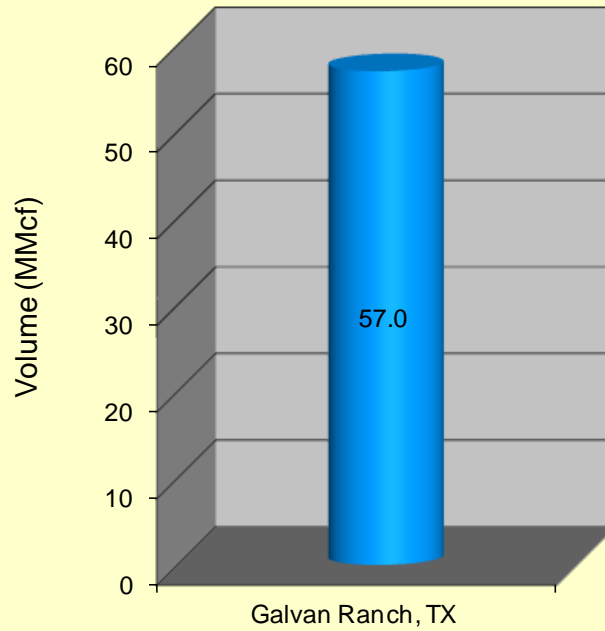

Imports from Canada by Entry Point



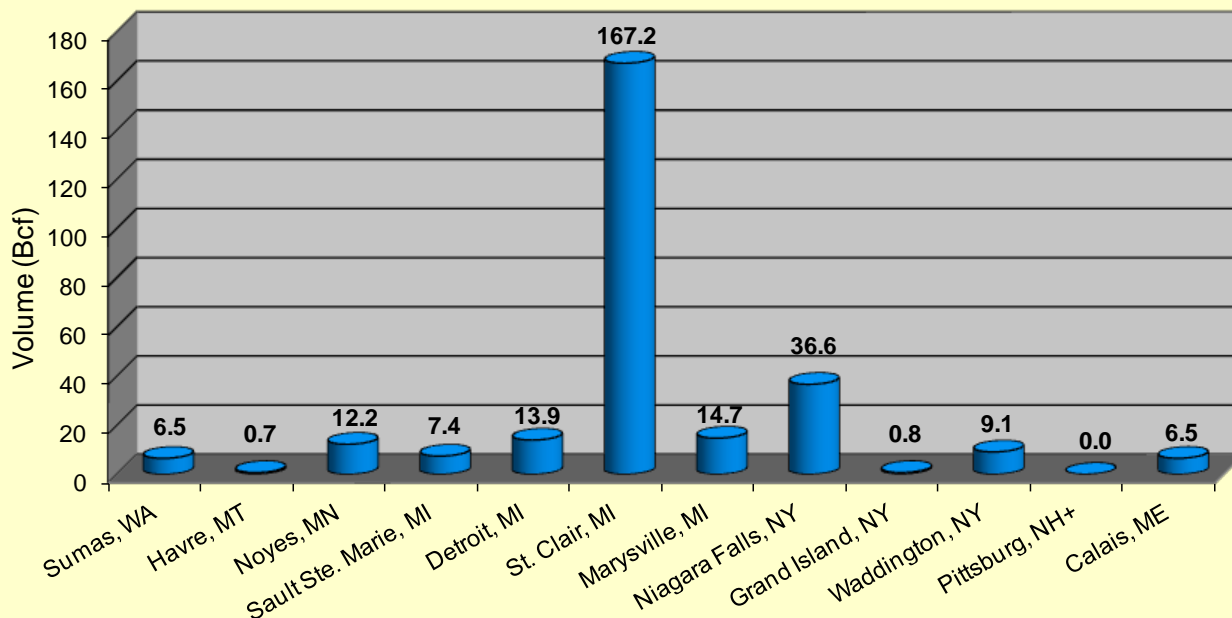
- Continuing a long-term trend, volumes of natural gas imported under short-term authorizations eclipsed volumes imported under long-term authorizations.

- These three points handled almost two-thirds of all imports from Canada during the first quarter.
- Unlike other points, the vast majority of imports at Calais, Maine were under a long-term authorization with only a small amount under short-term authorizations.

- Continuing a trend of diminishing imports from Mexico in recent years, only a very small volume of natural gas was brought into the country from Mexico, through only one entry point, during the first quarter.

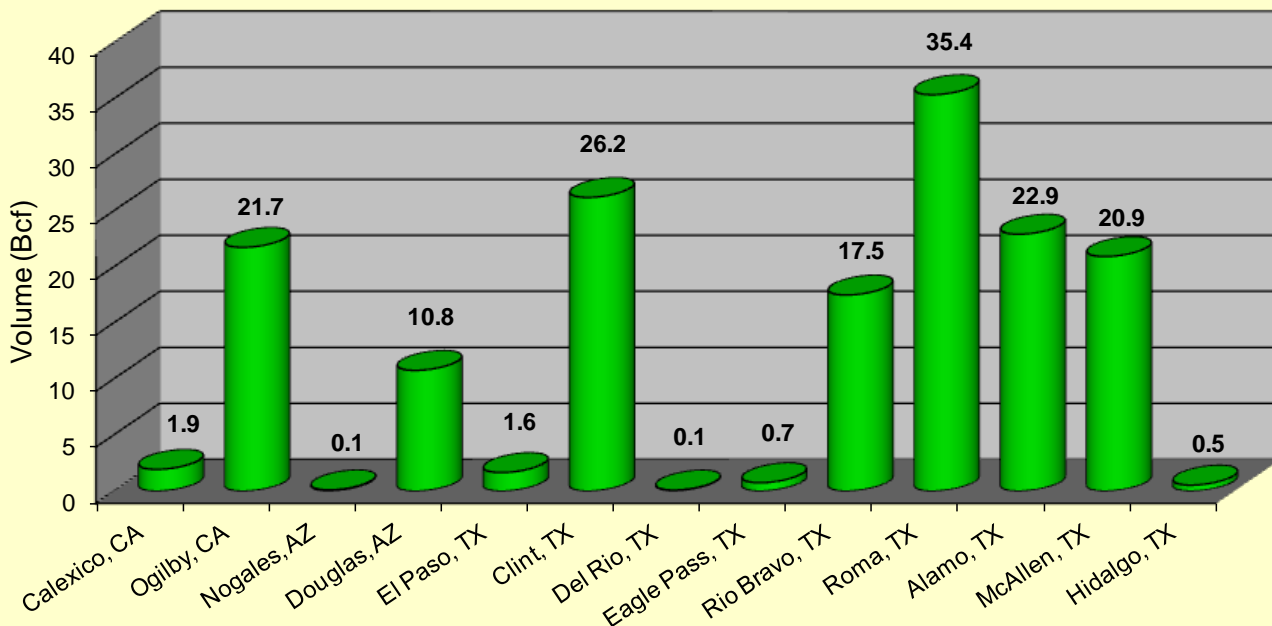
Pipeline Exports to Canada by Exit Point

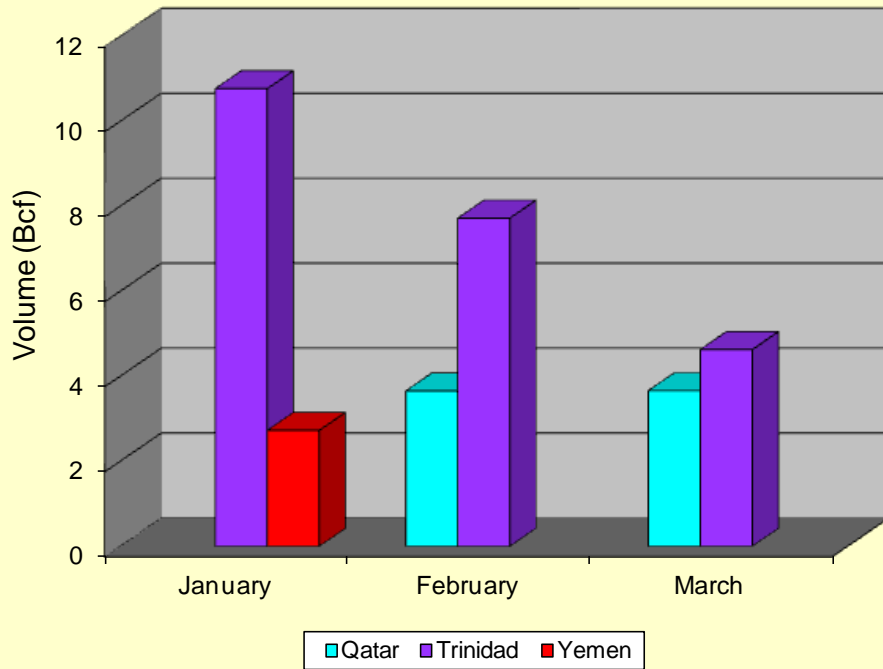
- St. Clair, Michigan continued to dominate export points, accounting for over 60% of exports to Canada in the first quarter. Many points handled much smaller volumes of exports.

- Typical of recent experience, the U.S. exported natural gas to Mexico through a large number of exit points during the first quarter. Seven points (Ogilby, California; Douglas, Arizona; Clint, Texas; Rio Bravo, Texas; Alamo, Texas; Roma, Texas; and McAllen, Texas) together accounted for about 97% of total Mexican exports. The other six points used during the quarter handled much smaller volumes.

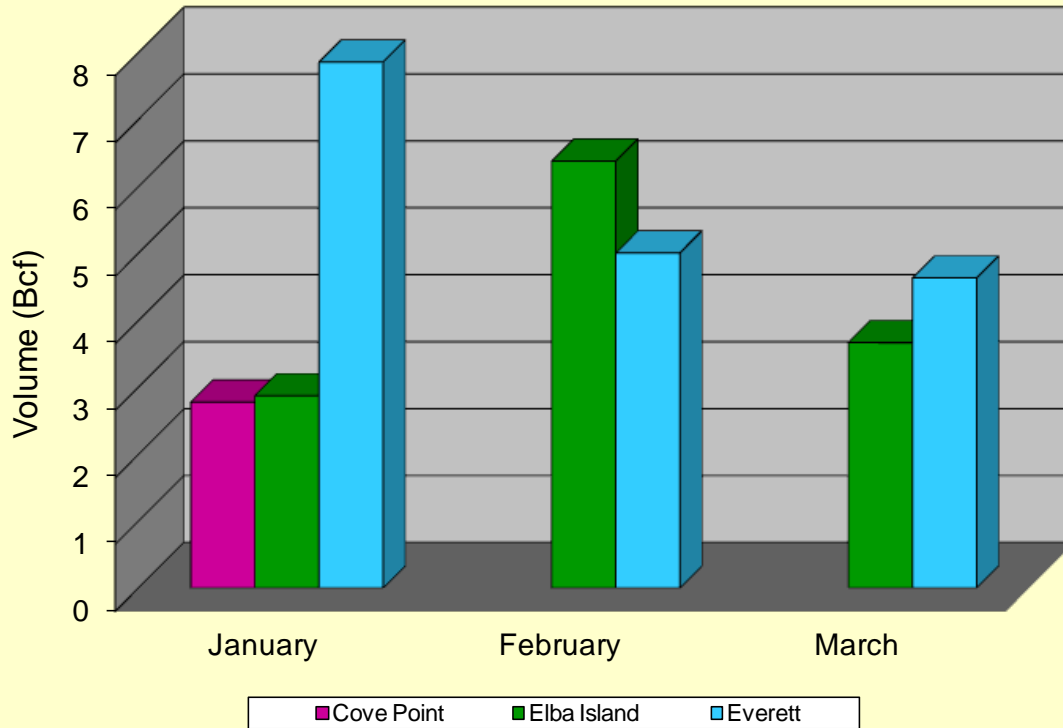
LNG Import Volume by Country 1Q 2013

LNG Imports by Terminal, 1Q 2013

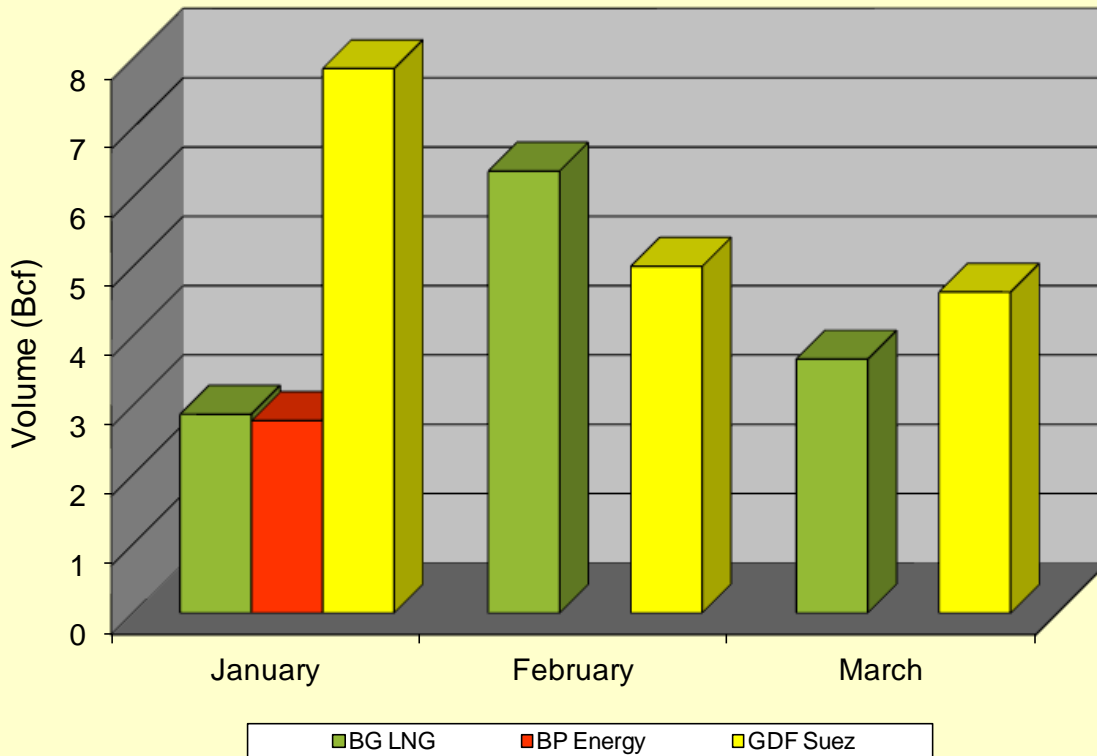
