Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

**B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

**Rational for determination:**

This NEPA determination (GFO-09-332-004) is a result of a previous NEPA determination (GFO-09-332) conditioning OK's Revolving Loan Fund. OK's Department of Central Service, Fleet Management Division would use DOE funding for 105 Fleet Vehicle CNG Conversions.

The Department of Central Services would perform 105 total (75 sedans and 30 pickup trucks) alternative fuel vehicle conversions during the three-year grant period. State Energy Program funding of \$1,000,000 would be used to offset the incremental cost of conversion to dedicated CNG alternative fuel.

The fuel system conversions will occur at either the State's central maintenance facility on Santa Fe Avenue in Oklahoma City or at locations with approved conversion technology installers who are also Certified Alternative Fuels Technicians by the State of Oklahoma.

In the performance of work in all program areas, grantees will be required to comply with all applicable federal, state and local laws, regulations and standards, including but not limited to the handling, storage, transportation and disposal of waste. If a grantee proposes work that may affect an historic property or archaeological resource listed in or determined to be eligible for the National Register of Historic Places, the grantee will be required to comply with the requirements of Section 106 of the National Historic Preservation Act.

This project comprises actions to conserve energy; therefore it is categorized under CX B5.1.


