Description:

- B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.
- A9** Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.
- A11** Technical advice and planning assistance to international, national, state, and local organizations.

Rational for determination:

Kentucky's Department of Local Government ("DLG") will administer the EECBG Program for the state of Kentucky. DLG would pass through DOE funding to sub-recipients for the implementation KY's "Small Cities and Counties Initiative." All projects under this Initiative are bounded in compliance with the uploaded and signed EECBG Template for Expedited NEPA review.

Any projects that fall outside the scope of the template are conditioned pending further NEPA review.

These projects comprise education, technical advice, and actions to conserve energy; therefore they are categorized under CX A9, A11, and B5.1.
