Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

This NEPA determination (GFO-10-147-001) is a result of prior NEPA determination (GFO-09-224) and lifts a condition placed on Market Title Clean Energy Supply Chain Development. Wisconsin's Office of Energy Independence would pass DOE funding to Helios, USA, LLC.

Helios USA's office in Milwaukee, WI would use a \$1M SEP loan to purchase the following equipment:

stringer assembler,
a laminator
a flash tester,
a forklift, and
computers.

Helios USA would also use DOE funding for: working capital.

No new permits, licenses or approvals will be needed for the expenditures of these funds.

Waste Stream Requirements

Prior to the expenditure of Federal funds to implement any of the above-mentioned activities, the State of Wisconsin has the affirmative responsibility to ensure or certify that it has been provided by its sub-recipients a waste management plan addressing waste generated by their proposed actions.
