Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

This NEPA determination (GFO-10-147-004) is a result of prior NEPA determination (GFO-09-224) and lifts a condition placed on Market Title Clean Energy Supply Chain Development. Wisconsin's Office of Energy Independence would pass DOE funding to Nature Tech.

Nature Tech's facility in Milwaukee, WI would use a \$800K SEP loan for receivable, payroll and the following inventory:

recycled newspaper;
plastic liners and bags; and
fire retardant for the insulation

No new permits, licenses or approvals will be needed for the expenditures of these funds.

Waste Stream Requirements

Prior to the expenditure of Federal funds to implement any of the above-mentioned activities, the State of Wisconsin has the affirmative responsibility to ensure or certify that it has been provided by its sub-recipients a waste management plan addressing waste generated by their proposed actions. The plan will describe the sub-recipients plan to dispose of any sanitary or hazardous waste, e.g. construction and demolition debris, old light bulbs, lead ballasts, piping, roofing materials, discarded equipment, debris, asbestos, etc. generated as a result of the proposed project. The sub-recipients must ensure that it will comply with all federal, state and local regulations for waste disposal.

NHPA Requirements

Prior to the expenditure of Federal funds to implement any of the above activities, the State of Wisconsin has the affirmative responsibility to ensure the sub-recipient is in compliance with Sec. 106 of the National Historic Preservation Act (NHPA), consistent with DOE's 2009 letter of delegation of authority regarding the NHPA. 
