**Activity 3 - Solar Power Retrofit of Multi-Purpose Facilities**

Prohibited actions include: Demolition, construction, removal, installation or disposal activities, until such time that Recipient complies with the Waste Stream clause, Historic Preservation clause, and Engineering Clause.

This restriction does not preclude Recipient from: (1) purchasing any necessary equipment or related materials; (2) conducting assessments, studies and other related administrative work

**Activity 4 - Energy Efficiency and Conservation Through the Installation of LED Lights**
