Description:

- A11** Technical advice and planning assistance to international, national, state, and local organizations.
- A9** Information gathering (including, but not limited to, literature surveys, inventories, audits), data analysis (including computer modeling), document preparation (such as conceptual design or feasibility studies, analytical energy supply and demand studies), and dissemination (including, but not limited to, document mailings, publication, and distribution; and classroom training and informational programs), but not including site characterization or environmental monitoring.
- B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The following Project Activity Sheets (PAS) are bounded by the allowable project descriptions provided in Part I - Bounded Categories of the signed SOW and are therefore categorically excluded from further NEPA review under A9, A11 and B5.1: #2 Energy Audit and Efficiency Improvements at Prison, #3 Municipal Energy Conservation Grant Program, #4 Transportation Efficiency Program for County Employees, and #5 Energy Conservation Plan and Action Strategy.

Transportation Efficiency Program Strategies to be implemented under PAS #4 Transportation Efficiency Program for County Employees are limited to the following:

- Enhancing existing and develop additional transportation incentive programs
- Developing site specific and individualized marketing of incentive programs
- Setting aside more existing parking spaces as carpool spaces
- Creating a carpool matching program to coordinate carpools among employees

Any projects submitted for EECBG funding that fall outside the the allowable project descriptions provided in Part I - Bounded Categories of the signed SOW will require a separate NEPA determination review.
