Description:

**B5.1** Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

## Rational for determination:

The Illinois Department of Commerce & Economic Opportunity will provide A. Lucas & Sons Steel with \$350,000 in Recovery Act funds to improve the production capabilities of the facility. The improvements will allow the plant to produce wind turbine steel components.

The equipment includes an automated beam processing tool and coping system (Voortman V806M Coping System), which would be installed inside the existing A. Lucas & Sons Steel facility in Peoria, Illinois. The Voortman V806M will replace old tools and equipment at the facility, thus allowing for the needed increased production. The equipment changes will not require a change or modification to existing operation permits.

This activity comprises actions to improve energy conservation through the purchase of equipment that will improve manufacturing capabilities. This activity is consistent with the provisions under categorical exclusion B5.1.
