American Recovery and Reinvestment Act:

1) Energy efficiency and conservation strategy, 2) energy efficiency lighting retrofits of Martin Middle School to high-efficiency lighting with automated controls, 3) building retrofits/renovation of a section of roof at Martin Middle School with a new waterproof membrane insulation and installation of a vegetative roofing system, 4) installation of outdoor lighting control system in school district, and 5) installation of a roof-top solar photovoltaic system (10 kW).
