Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

The State of Indiana will provide \$5,000,000 in Recovery Act funds to General Electric Appliances for the purchase of equipment to modify production lines at its existing facility located at 301 North Curry Pike, Bloomington, Indiana 47404 (Monroe County).

The recipient intends to purchase machinery and tooling that will enable the production of high energy efficient side-by-side refrigerators. The recipient does not anticipate the need for new or modified plant permits. The equipment purchases and production line complement work already ongoing at the plant. The work will not increase the footprint of the facility.

In view of the information provided by the State and recipient, DOE has determined that the work outlined is consistent with activities identified in Categorical Exclusion B5.1.
