Proposed Action or Project Description:

American Recovery and Reinvestment Act:

1) Develop comprehensive strategy for energy efficiency and conservation at municipally owned buildings and infrastructure; 2) energy efficiency building retrofits at 515 Columbia Street: HVAC, water heater, lighting, green roof, and windows; 3) install centralized traffic management system; 4) installation of a closed-loop geothermal heating and cooling system (<20 tons) for Fire Station #5; 5) retrofit lighting of city-owned parking garage; and 6) replace incandescent pedestrian-head assemblies with LED assemblies at intersections.

Conditions: Historic preservation clause applies to this application
