Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rational for determination:

DOE is proposing to provide federal funding to Siemens Energy, Inc. (Siemens) to research wind turbine designs that reduce the aerodynamic loads turbine rotors experience during power production. This NEPA determination only applies to Budget Period 1 activities. Budget Period 2 will require additional NEPA review.

The proposed project would develop new blade designs and modifications. The designs would be applied to existing Siemens blades through structural computer modeling. Siemens would also work with NREL to develop a Cost of Energy (COE) model and to develop a prototype testing plan for Budget Period 2 activities.

Based on this information, DOE has determined the work outlined is consistent with activities identified in categorical exclusion A9 (information gathering, analysis and dissemination).

NEPA PROVISION

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.

Insert the following language in the award:

You are restricted from taking any action using federal funds, which would have an adverse affect on the environment or limit the choice of reasonable alternatives prior to DOE/NNSA providing either a NEPA clearance or a final NEPA decision regarding the project.

If you move forward with activities that are not authorized for federal funding by the DOE Contracting Officer in advance of the final NEPA decision, you are doing so at risk of not receiving federal funding and such costs may not be recognized as allowable cost share.
