Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, laboratory operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rational for determination:

Applied Technology Associates (ATA) would utilize DOE and cost share funds to develop a seismic measurement tool for high-temperature geothermal applications. Phase I of this work would consist of research, development, and modeling of rotational seismometer technologies. Laboratory work would be conducted at the sensor manufacturing facility and test laboratories at A-Tech, Corp. dba Applied Technology Associates corporate headquarters, 1300 Britt, SE, Albuquerque, NM 87123.

This project includes two Phases but this NEPA review is for Phase I only. Prior to initiating Phase II activities, there would be a go/no-go decision point after which DOE would determine whether to fund Phase II activities. Additional NEPA review will be required if this project is selected to continue with Phase II activities.

Project Management and Reporting
Phase I

1. Elicit Detailed Requirements
2. Establish High Temperature Components
3. Model Sensor Technology
4. Rotational Sensing Proof-of-Concept
5. Trade and Down-Select
6. Solidify Initial Development Plans
7. Document and Publish

Phase II (tasks 8 through 16) will require additional NEPA review if the project is selected to continue with Phase II activities.

There is no fieldwork associated with Phase I of this project.

According to the R&D laboratory questionnaire, no additional permits are needed for project activities. No air pollutants would be produced from this work during Phase I activities. Chemicals and solvents are handled with appropriate safety equipment and protocols and stored in appropriate containers. ATA uses a Hazardous Waste Disposal Service to dispose of any hazardous waste. There is an Emergency Action Plan in place.

Phase I Budget: \$519,683 (DOE) \$129,920 (cost share)

Phase I of this project is comprised of information gathering, analysis, and dissemination; and laboratory operations; therefore the DOE has categorized this into Categorical Exclusions A9 and B3.6.

NEPA PROVISION

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.


Phase I (all tasks)
