Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. A11 Technical advice and assistance to organizations

Technical advice and planning assistance to international, national, state, and local organizations.

B3.14 Small-scale educational facilities

Siting, construction, modification, operation, and decommissioning of small-scale educational facilities (including, but not limited to, conventional teaching laboratories, libraries, classroom facilities, auditoriums, museums, visitor centers, exhibits, and associated offices) within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Operation may include, but is not limited to, purchase, installation, and operation of equipment (such as audio/visual and laboratory equipment) commensurate with the educational purpose of the facility.

Rational for determination:

This NEPA determination applies to an additional location for a mock roof installation associated with Hudson Valley Community College Northeast Photovoltaic Regional Training Provider project (GFO-10-237; CX A9, A11 and B5.1; signed 3.4.2010) applied to Phase 1. This additional location is also part of Phase 1.

Hudson Valley Community College's sub-recipient Erie Community College (ECC) proposes to use federal funding to purchase equipment for a mock roof system to support the solar photovoltaic (PV) educational "Train the Trainer" program. Project activities would also include curriculum development and outreach activities.

ECC would construct a mock training roof and a small, pole-mounted PV array at 4196 Abbot Road, Orchard Park, New York 14203. ECC's campus is located 3 miles east of Lake Erie between Ralph Wilson Stadium and McKinley Mall. The proposed site is a graded and seeded yard with an existing school alumni house and weatherization pressure house that is under construction.

The proposed project would require minor excavation and trenching for conduit and footing installation. The mock roof would be approximately 14 feet x 28 feet and would have PV equipment installed and periodically removed for training. The PV pole mount system would consist of one pole extending a minimum of 8 feet tall with 10 to 14 PV panels installed permanently for instruction and data collection.

Based on this information, DOE has determined the work outlined is consistent with activities identified in categorical exclusion A9 (information gathering, analysis and dissemination), A11 (technical advice and assistance to organizations) and B3.14 (small-scale educational facilities).


