Rational for determination:

The U.S. Department of Energy (DOE) provided \$1,933,000 of federal funding to the California Energy Commission (CEC) under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. The CEC will match the federal funding with \$386,665 in state funds.

The CEC proposes to fund the following Market Titles:

Appliance Efficiency Program:

Under this Market Title, CEC would utilize federal funding to develop, implement, and enforce standards which require either appropriate minimum efficiencies or maximum energy consumption allowances for each type of affected appliance. CEC would perform a market survey and modernize their Appliance Efficiency Program's database through contracts to third-party vendors. This program is strictly administrative in nature.

Building Efficiency Program:

Under this Market Title, CEC would utilize federal funding to implement and coordinate the CEC's Building Efficiency Program. This program is strictly administrative in nature.

Based on a review of the activities that would be funded under the above Market Titles, DOE has determined the projects that would be funded under these Market Titles will not significantly impact the human environment and they are categorically excluded from further NEPA review under CX A9 "information gathering" and CX A11 "technical advice." Any activities funded under the 2012 annual appropriations that involve ground-breaking activities, retrofits, or equipment purchase and/or installation are conditioned pending additional NEPA review.


