**A. Brief Description of Proposal:** Western Area Power Administration (Western) will replace transformer KV1A at the Archer Substation. The substation is located in township 14 North, range 65 West, Section 27 of Laramie County, Wyoming, at longitude 104° 38' 57" West, latitude 41° 8' 43" North. The existing 220/115/13.8-kV, 166.7 MVA transformer KV1A is composed of three single phase 220/115-kV 55.5 MVA transformers. The A-phase (KV1A3) failed, but with the use of the mobile transformer KV1A still operates at a reduced capacity of 100 MVA. Western will replace this configuration with a single multi-phase unit. The new unit will be a 3-phase 230/115/13.8-kV 200 MVA transformer which will be installed in the same general location as the existing KV1A units. The work will include:

- 1) Removal of three 55.5 MVA single phase transformers.
- 2) Demolition and removal of existing concrete slabs.
- 3) Construction of permanent concrete slab.
- 4) Place, assemble, and fill new 200 MVA transformer onto permanent slab.

The total amount of oil for KV1A will change from 24,600 gallons to 27,211 gallons of oil. All work will be conducted within the fence of the Archer Substation and there will be no modification to the access road. The removed transformer and oil will be recycled per Western's contractual procedures.

**B. Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

**B4.6. Additions and modifications to transmission facilities.**

Additions or modifications to electric power transmission facilities within a previously disturbed or developed facility area. Covered activities include, but are not limited to, switchyard rock grounding upgrades, secondary containment projects, paving projects, seismic upgrading, tower modifications, load-shaping projects (such as the installation and use of flywheels and battery arrays), changing insulators, and replacement of poles, circuit breakers, conductors, transformers, and crossarms.

**C. Regulatory Requirements in 10 CFR 1021.410 (b):** (See full text in regulation and attached checklist.)

- 1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;

- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
  - Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

**D. Special Stipulations Pertaining to the Proposal:**

If the scope of work of this project changes, Western’s Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion is valid for 3 years after the signature date. If construction has not commenced within that time, Western’s Environmental Division must be contacted for an updated environmental review prior to construction.

The findings of this Categorical Exclusion depend on the contractor’s execution of, or compliance with, Western’s construction specifications for the project, specifically, Division 13 – Environmental Quality Protection.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western and the Wyoming SHPO staff shall be contacted, and the material be evaluated by and archaeologist or historian meeting the Secretary of the Interior’s Professional Qualification Standards (48 FR 22716, Sept. 1983).
