Rational for determination:

The Department of Energy (DOE) is proposing to provide federal funding to Johnson County Community College to install an 18kW, 2,000 square foot rooftop-mounted solar photovoltaic (PV) array on the existing College Commons Building (COB) built in 1970. This proposed project would include installation and operation of the PV array on the rooftop of the COB to be used as a demonstration/teaching opportunity.

A previous determination (GFO-10-512) was approved on 7/29/2010, allowing:

- curriculum development, equipment purchasing for energy auditor, and solar technician trainings, and community outreach activities
- 5kW turbine on a 90 foot pole on campus next to an academic building.
- 2 kW solar array mounted on an existing concrete slab or gravel area next to academic buildings.

However, the 5kW turbine was dropped from the proposal and replaced with an 18kW, 2,000 square foot rooftop-mounted PV array. This review is for the 18kW, 2,000 square foot rooftop-mounted PV array on the COB. Installation and operation would be conducted according to applicable state and federal safety laws, and regulations. Due to the age of the COB, the building is not eligible for listing on the historic register and there are no other historic properties in the vicinity that would be impacted by this proposed action.

This project comprises information dissemination (classroom training and informational programs) and installation and operation of a solar photovoltaic system; therefore the DOE has categorized this project into Categorical Exclusions A9, and B5.16.
