1) Building shell improvements (incidental costs associated with HVAC project); 2) building energy efficiency lighting retrofits (Liberty Hall, Veterans Hall, Senior Center, and Administration Building); 3) HVAC removals and replacements (Veterans Hall, Administration Building, and Liberty Hall) and removal and installation of associated duct work and piping, installation of sensors, replacement of service panels, etc.; and 4) building commissioning/recommissioning, and building energy auditing/monitoring of facilities and preparation of reports.
