Proposed Action Title: Davis Dam to Kingman Tap 69-kV Transmission Line, Overhead Optical Power Ground Wire Installation

Program or Field Office: Western Area Power Administration, Desert Southwest Regional Office

Location(s) (City/County/State): Bullhead City, Mohave County, Arizona

Proposed Action Description:

Western proposes to install new overhead optical power ground wire (OPGW) on the existing Davis Dam to Kingman Tap (DAD-MKT) 69-kV transmission line near Bullhead City, Mohave County, Arizona. The project is located on lands administered by the National Park Service in Township 21 North, Range 21 West, Section 19 (Gila & Salt River Baseline and Meridian). The purpose of the project is to establish a redundant communication path from Bullhead substation to the Davis Dam substation.

The scope of work includes removing the old static wire and installing OPGW on four existing DAD-MKT structures (0-4, 0-3, 0-2, 0-1), a Bullhead substation take-off structure, and a take-off structure within the Davis Dam 69-kV switchyard. Work will occur within about a 50-foot-radius area around each structure. Temporary disturbance may occur within these work areas due to overland travel; no blading will occur at the structure pads. Work vehicles will use existing public roads and rights-of-way. A maximum 4-foot trench will be dug between the base of the take-off structure within the Davis Dam 69-kV switchyard and an existing cable duct bank. No trenching will take place at Bullhead substation (owned by Mohave Electric Co-op) as part of this project. Project activities are anticipated to start no sooner than December 1, 2013, and be completed by February 28, 2014.

Special Condition: A biological monitor will be present for project activities. The biological monitor shall perform duties as described in the "Environmental Assessment for the Davis-Kingman Tap 69-kV Transmission Line Rebuild" (August 2011).

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.

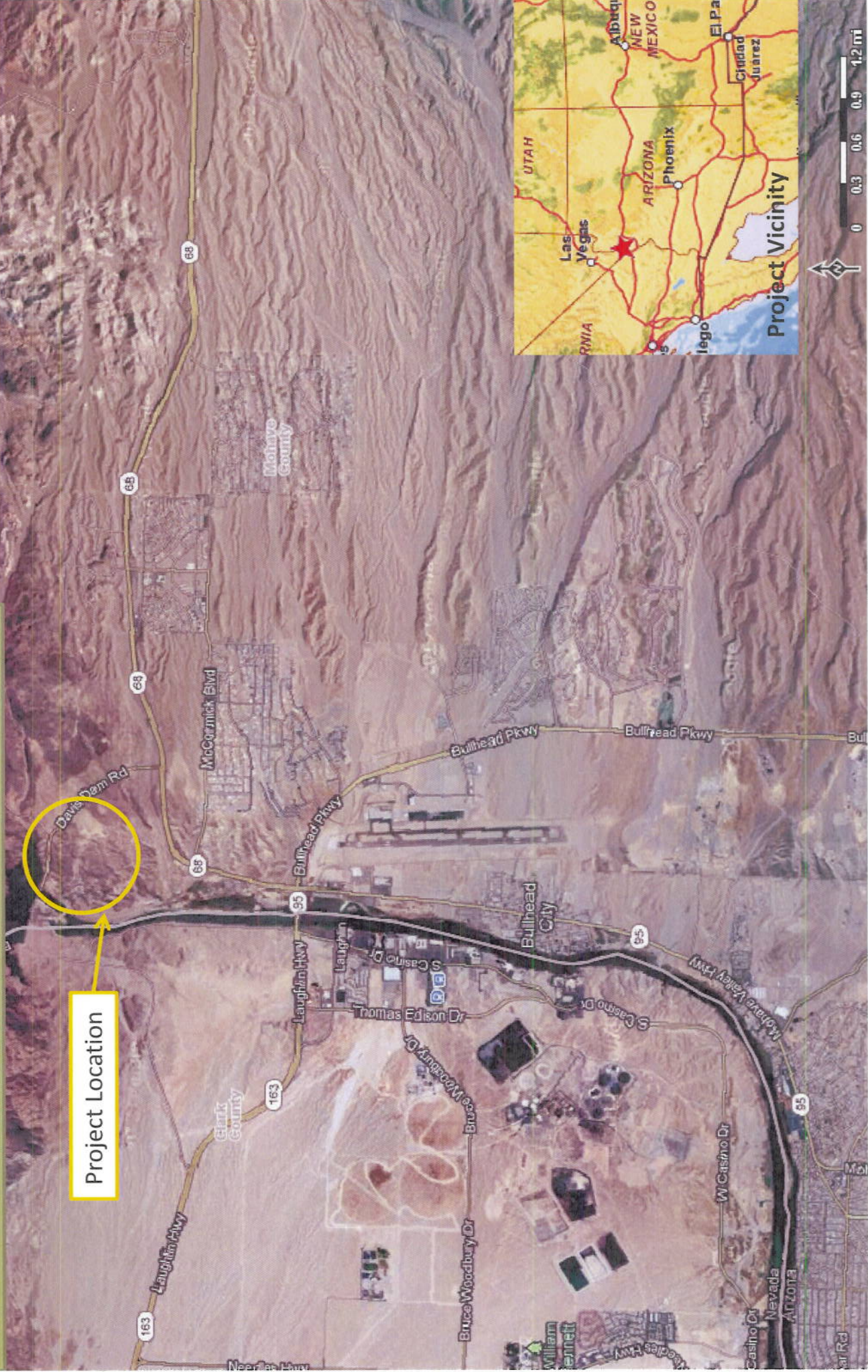
