Proposed Action Title: GCS Switchyard - 230kV Wavetrap Removal - TZ9A2 on the Navajo Line

Program or Field Office: Western Area Power Administration, Desert Southwest Regional Office

Location(s) (City/County/State): Page, Coconino County, AZ

Proposed Action Description:

Western proposes to remove 230kV wavetrap (TZ9A2) at the Glen Canyon Switchyard (GCS) located on the Navajo (NAV) transmission line. GCS facility is located in Sections 24 and 25, Township 1N, Range 8E in the city of Page, Coconino County, AZ. The project site is on BLM "withdrawn property" that is transfer of use for Western's right to facilitate its operation of switchyard.

Wavetraps are used in switchyard to prevent high frequency carrier from entering the station equipment. It is connected in series with the power (transmission) line. Wavetrap is a filtering device employed to separate the high voltage power and communication signals at every receiving end of the grid. The wavetrap is no longer in service and removal is necessary to provide increased power flow on the GCS-NAV 230kV line. The need for the work will provide continued safety and reliable operation of the bulk transmission system.

No ground disturbance or excavation will occur as part of the proposed action. All work performed will utilize existing access roads to carry equipment and personnel to the project site. Equipment used on site may consist of rubber tire equipment (e.g. manlift, line truck, and pick up trucks).

The anticipated start date for the work is October 2013 due to outage schedule requirements and completed by May 2014. Scope of work is no more than one week to carry out.
