Description:

**A9 Information gathering, analysis, and dissemination** Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

**A11 Technical advice and assistance to organizations** Technical advice and planning assistance to international, national, state, and local organizations.

**Rationale for determination:**

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Mid-America Regional Council (MARC) to expand collaborative approach of the 2012 Solar Ready KC initiative to a national scale, using established relationships among regional planning councils and their member local governments. The recipient would work with local and state governmental agencies to adopt solar-friendly best management practices. This would be accomplished through research, education, outreach and face-to-face discussions with local and state government officials.

Based on review of the project information and the above analysis, DOE has determined the information gathering and technical advice activities would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed project is consistent with the actions contained in DOE categorical exclusions A9 "information gathering, analysis, and dissemination," and A11 "technical advice and assistance to organizations," and is categorically excluded from further NEPA review.
