Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. A11 Technical advice and assistance to organizations Technical advice and planning assistance to international, national, state, and local organizations.

Rationale for determination:

Electric Power Research Institute, Inc. (EPRI) is proposing to use DOE funding to develop training and educational capabilities that will incorporate the outcomes of renewable energy industry and academic research and development studies.

EPRI would develop short courses, tutorials, workshops, and symposia programs to achieve their academic initiatives in developing a professional renewable energy related training courses and degree programs. Their efforts would also involve engaging utility stakeholders to identify knowledge gaps and the required skill sets that students may need prior to entering the workforce.

EPRI's project activities are exclusively planning, paper studies, computer programming, community outreach and engagement, classroom training and information dissemination.

DOE has determined that this project is consistent with actions covered under DOE CX A9 (information gathering, dissemination, desktop research and classroom training) and CX A11 (Technical advice and planning assistance to local organizations); and therefore is categorically excluded from further NEPA review.


