Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to New Mexico State University (NMSU) to complete Phase 1/Task 1 process and data validation activities which would allow DOE to collect the data and information required to analyze the proposed project's readiness to proceed, their technology readiness level and the current state of their technology.. These activities would allow the DOE to make a critical Go / No Go decision on funding NMSU's "Realization for Algae Potential (REAP)" project under DOE's DE-FOA-0000811 - Advancements in Algal Biomass Yield Funding Opportunity Announcement. NMSU's proposed project would develop an integrated process for producing at least 3,500 gallons of algal bio-fuel intermediate per acre per year within 30 months

This NEPA determination covers Phase 1/Task 1 which would include project management and data collection and analysis activities such as LCA (Life Cycle Analysis), TEA (Techno-Economic Analysis), resource assessments and risk analysis. All activities are administrative and analytical in nature and would not involve physical experiments, field tests, land-disturbing, construction or similar activities.

Based on review of the project information and the above analysis, DOE has determined the information gathering and data analysis activities would not have a significant individual or cumulative impact to human health and/or environment. DOE has determined the proposed project is consistent with the actions contained in DOE categorical exclusion A9 "information gathering, analysis, and dissemination," and is categorically excluded from further NEPA review.

NEPA PROVISION

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.

You are restricted from taking any action using federal funds, which would have an adverse affect on the environment or limit the choice of reasonable alternatives prior to DOE/NNSA providing either a NEPA clearance or a final NEPA decision regarding the project.

Prohibited actions include:

Any Phases or Tasks outside of Phase 1/Task 1.

This restriction does not preclude you from:

Phase 1/Task 1 activities.

If you move forward with activities that are not authorized for federal funding by the DOE Contracting Officer in advance of the final NEPA decision, you are doing so at risk of not receiving federal funding and such costs may not be recognized as allowable cost share.
