Proposed Action Title: Lone Butte Substation Erosion Repairs

Program or Field Office: Western Area Power Administration/ Desert Southwest Region

Location(s) (City/County/State): Gila River Indian Community, Maricopa County, Arizona

Proposed Action Description:

Western plans to prevent further rain and run-off damage and repair damage to Lone Butte Substation's gravel base. The substation is located west of State Route 347 near the junction with Queen Creek Road, on the Gila River Indian Community, Maricopa County, Arizona. Gila River Indian Community owns the land. The substation was constructed on gravel-covered earthen base that rises 8 feet above the surrounding ground surface.

The work entails returning the base to the original grade by adding fill, such as river rock, to newly formed or expanded erosional gullies located inside and outside the perimeter fence. Western plans to use a backhoe and a tracked front-end loader to accomplish the work. Western plans to drive equipment on the gravel access road leading from State Route 347 and the dirt access road around the substation's perimeter. No road improvements are planned. Western plans to begin this work on 10/2/15.

The purpose of the work is to ensure the safety and reliability of the bulk electric system. Recent rains eroded the substation's gravel base creating gaps under the perimeter security fence, exposing concrete footings of some fence posts, and exposing ground wires that are part of Western's safety equipment.

Special Conditions: Western will conduct a pre-construction survey for burrowing owls or their nests.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.

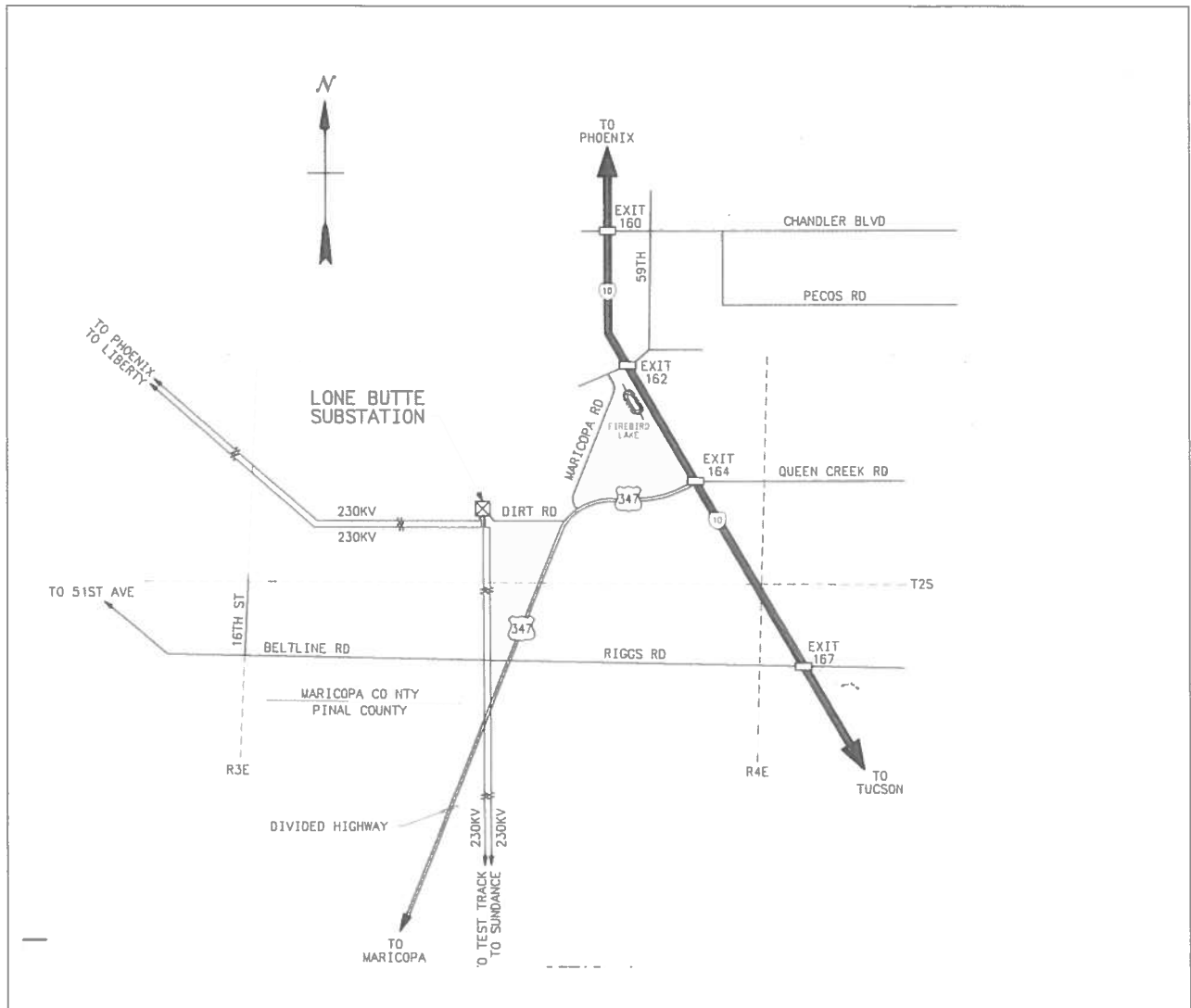
