Proposed Action Title: Issuance of Easement Outgrant to Giving Life Ministries for a Parking Lot Expansion

Program or Field Office: Western Area Power Administration, Desert Southwest Region

Location(s) (City/County/State): Henderson, Clark County, Nevada

Proposed Action Description:

Western Area Power Administration (Western) has received a request from Giving Life Ministries to expand their parking lot into Western fee-owned land in Henderson, Clark County, NV (see attached map). The new parking lot would be approximately 0.9 acres. The subgrade will extend 1 to 2 feet deep and nine 30-inch diameter light poles will extend about 60 inches deep. No fill would be used in the construction of this parking lot. A small portion of the proposed project location involves Western's fee-owned land located at the corner of Perlite Way and West Victory Road (enclosure 4; labeled "Utility's Lot"). The proposed location is a heavily disturbed dirt lot that has been leveled and bladed and is used unofficially by local residents as a parking lot.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
