Proposed Action Title: Glen Canyon Substation Emergency Waterline Repairs

Program or Field Office: Western Area Power Administration, Desert Southwest Region

Location(s) (City/County/State): Coconino County, Arizona

Proposed Action Description:

Western Area Power Administration (Western) proposes to repair a broken waterline that is the sole water source for workers stationed at Glen Canyon Substation. The substation is located outside of Page, Coconino County Arizona. It occurs within portions of Section 24 in Township 41 North, Range 8 East on the Gila and Salt River Baseline and Meridian. Western owns, operates and maintains this facility on behalf of Colorado River Storage Project Power System customers.

The waterline exits the northeast side of the substation, heads north, crosses under US 89, and connects to a water main situated on Bureau of Reclamation property for Glen Canyon Dam. As soon as possible, Western plans to have the contractor who repaired a leak in this same area on 1/29/2016 investigate the new leak to determine if the previous repair failed or if it originates from a different section. The waterline consists of a two-inch diameter pipe, placed typically one to six inches below the ground surface in a six-inch-wide trench. The leak is evident on the south side of US 89, where it enters a four-inch-diameter sleeve that passes under the highway. Western plans to use existing access roads to reach the work area. Western may use a track hoe or backhoe to re-excavate the water line trench.

If the leak cannot be fixed or occurs in a portion of the line that Contractor did not repair earlier or cannot easily fix, then Western plans to consider reconstructing the waterline as a separate action.

Special Conditions:

1. If any damage is done to the detention dikes or gravel berms, then they will need to be repaired to satisfy secondary containment requirements for Glen Canyon sub.
2. If clearing, grading, and excavating activities disturbs one or more acres and discharges storm water to navigable waters, then storm water regulations will apply. Contractor will need to submit Notice of Intent (NOI) to ADEQ, to receive a Construction Storm water permit. Contractor will also be responsible for preparation and implementation of the Storm Water Pollution Prevention Plan (SWPPP). Disturbed areas include staging, parking, fueling, stockpiling, and any other construction related activities.
3. In the event that archaeological materials or human remains are discovered work must cease immediately in the vicinity of the discovery, the materials protected, and the DSW Environmental Manager contacted immediately.
