Proposed Action Title: Materials & Systems Research, Inc. - Advanced sodium batteries with enhanced safety and low cost processing

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Salt Lake City, UT; San Antonio, TX

Proposed Action Description:

Funding will support small-scale, research and development activities to continue efforts to demonstrate a new sodium beta alumina battery that enhances safety and reduces production cost through an innovative cell design and a low-temperature processing method. Project activities will include powder synthesis, plasma spraying, material characterization, battery assembly, battery testing, and sputter deposition. If successful, the project will provide a low cost manufacturing method for grid scale sodium batteries.

Project activities will be conducted at existing facilities, and will be conducted in accordance with applicable Federal, State, and local safety and environmental requirements.

Proposed Action Title: (0674-1634) Materials & Systems Research, Inc. - Advanced Na Battery with Enhanced Safety and Low Cost Processing

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Salt Lake City, UT

Proposed Action Description:

Funding will support efforts to develop a novel, low-cost Sodium-Sulfur battery manufacturing process.

Proposed work will consist of: (1) in lab design and fabrication of a single-cell battery to analyze different compositions of a thin film BASE and application of the thin film BASE battery components; (2) optimization and further testing of the thin film BASE based on early testing results; and (3) design and creation of a battery pack for analysis relative to project targets.

Some instrumental analysis will take place at the Nanofab laboratory at the University of Utah in Salt Lake City, UT. Activities will include analysis with scanning electron microscope and X-ray diffraction.
