Proposed Action Title: Rebellion Photonics, Inc. - goGCI - Portable methane detection solution

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Houston, TX

Proposed Action Description:

Funding will support efforts to develop goGCI: A portable, wearable, continuous gas detection and monitoring solution. The goGCI is a complete methane measurement system that is capable of detecting and characterizing gas leaks. By leveraging Rebellion Photonics' proprietary snapshot hyperspectral imaging technology the goGCI will detect and report concentration, leak-rate, location, and total volume of emissions. The goGCI will be attachable to hard hats or clothing akin to a GoPro camera. The goGCI will interface wirelessly with Google Glass and display real-time false color video overlay of the operator's field of view. goGCI devices can be worn by any number of personnel or mounted and installed to allow for continuous monitoring at each site. Any detections will be transmitted to a central database that can be used for universal methane emissions monitoring. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local requirements. While levels of methane released during any laboratory or field testing will be de minimis, applicable safety protocols will be followed.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
