Proposed Action Title: University of Colorado-Boulder - Frequency Comb-based Methane Observation Network

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Boulder, CO; Erie, CO; Gaithersburg, MD

Proposed Action Description:

Funding will support develop dual frequency comb spectrometers to enable sensitive, accurate measurements of multiple trace gases. In particular, the project will include: 1) the development of frequency comb laser spectrometers capable of simultaneously achieving both the ARPA-E methane detection goals and cost targets and 2) field tests of the spectrometers in the presence of simulated leaks to demonstrate achievement of the goals.

Design, construction, and laboratory testing of the comb spectrometers and peripheral equipment will be carried out in dedicated laboratory facilities. Calibration of a multi-gas analyzer and field tests will be carried out in dedicated laboratory facilities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local requirements. While levels of methane released during any laboratory or field testing will be de minimis, applicable safety protocols will be followed.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
