- A. **Brief Description of Proposal:** Western Area Power Administration (Western) proposes to conduct routine herbicide application for vegetation management in eastern Colorado and southern Wyoming at the following facilities:

**Eastern Colorado Maintenance Division Facilities – Communication Sites:**

- Akron Hill (AKH) – Washington County, CO
- Archer (ARW) – Laramie County, WY
- Bald Mountain (BDM) – Larimer County, CO
- Julesburg Hill (JUH) – Sedgwick County, CO
- Limon Repeater Tap-Limon Radio Site (LER-LRA) – Washington County, CO
- Merino (MER) – Logan County, CO
- Otis Radio Site/VHF (ORS) – Washington County, CO
- Peetz (PZ) – Logan County, CO
- Round Top (ROU) – Laramie County, WY
- Speer (SPE) – Laramie County, WY
- Weldona (WLM) – Morgan County, CO

**Colorado River Storage Project Facilities – Communication Sites:**

- Buford (BUF) – Albany County, WY

Bare ground control herbicides would be applied to all surface areas within the fenced perimeter and surrounding down guy wires at microwave sites; all graveled surfaces outside of the fence perimeter such as driveways and parking areas; and an additional five foot border outside the fenced perimeter, driveway, down guy wires, and parking areas. A selective post-emergence herbicide would be applied to control noxious weeds on adjacent property managed by Western. The herbicide used for this purpose would not kill grasses or other desirable vegetation. Treatment areas would be accessed using existing access routes, and no ground disturbance would occur.

- B. **Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

**B1.3. Routine Maintenance:**

Routine maintenance activities and custodial services for buildings, structures, rights-of-way, infrastructures (including, but not limited to, pathways, roads, and railroads), vehicles and equipment, and **localized vegetation and pest control**, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements. Custodial services are activities to preserve facility appearance, working conditions, and sanitation (such as cleaning, window washing, lawn mowing, trash collection, painting, and snow removal). **Routine maintenance activities, corrective (that is, repair), preventive, and predictive are required to maintain and preserve buildings, structures, infrastructures, and equipment in a condition suitable for a facility to be used for its designated purpose.** Such maintenance may occur as a result of severe weather (such as hurricanes,

floods, and tornados), wildfires, and other such events. Routine maintenance may result in replacement to the extent that replacement is in-kind and is not a substantial upgrade or improvement. In-kind replacement includes installation of new components to replace outmoded components, provided that the replacement does not result in a significant change in the expected useful life, design capacity, or function of the facility. Routine maintenance does not include replacement of a major component that significantly extends the originally intended useful life of a facility (for example, it does not include the replacement of a reactor vessel near the end of its useful life). Routine maintenance activities include, but are not limited to:

- (a) Repair or replacement of facility equipment, such as lathes, mills, pumps, and presses;
- (b) Door and window repair or replacement;
- (c) Wall, ceiling, or floor repair or replacement;
- (d) Reroofing;
- (e) Plumbing, electrical utility, lighting, and telephone service repair or replacement;
- (f) Routine replacement of high-efficiency particulate air filters;
- (g) Inspection and/or treatment of currently installed utility poles;
- (h) Repair of road embankments;
- (i) Repair or replacement of fire protection sprinkler systems;
- (j) Road and parking area resurfacing, including construction of temporary access to facilitate resurfacing, and scraping and grading of unpaved surfaces;
- (k) Erosion control and soil stabilization measures (such as reseeded, gabions, grading, and revegetation);
- (l) Surveillance and maintenance of surplus facilities in accordance with DOE Order 435.1, "Radioactive Waste Management," or its successor;
- (m) Repair and maintenance of transmission facilities, such as replacement of conductors of the same nominal voltage, poles, circuit breakers, transformers, capacitors, crossarms, insulators, and downed powerlines, in accordance, where appropriate, with 40 CFR part 761 ("Polychlorinated Biphenyls Manufacturing, Processing, Distribution in Commerce, and Use Prohibitions") or its successor;
- (n) Routine testing and calibration of facility components, subsystems, or portable equipment (such as control valves, in-core monitoring devices, transformers, capacitors, monitoring wells, lysimeters, weather stations, and flumes);
- (o) Routine decontamination of the surfaces of equipment, rooms, hot cells, or other interior surfaces of buildings (by such activities as wiping with rags, using strippable latex, and minor vacuuming), removal of contaminated intact equipment and other materials (not including spent nuclear fuel or special nuclear material in nuclear reactors); and
- (p) Removal of debris.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal must not:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
  - Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
  - Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; and
  - Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

#### **D. Special Stipulations Pertaining to the Proposal:**

If the scope of work of this project changes, Western’s Environmental Division must be contacted for additional environmental review.

**This Categorical Exclusion expires three years from the signature date.** If all project work has not been completed by the expiration date, or if need for an environmental compliance extension is anticipated, Western’s Environmental Division must be contacted for an updated environmental review.

The Contractor shall meet all applicable state licensing requirements for herbicide applicators and shall follow all applicable federal, state, and local laws, regulations, and guidelines. The contractor shall use only EPA-registered herbicides that are approved for the intended use and location, and shall follow all applicable label directions. Herbicides used near surface water such as wetlands, riparian areas, or streams and springs would be approved for use near aquatic environments.



If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 50 feet of the discovery area shall halt immediately, Western's archaeologist shall be contacted, and the resource shall be evaluated by an archaeologist or historian who meets the Secretary of the Interior's Professional Qualification Standards (36 CFR Part 61). Work in the area of discovery may not resume until notification is provided by Western's archaeologist.

Western shall exercise care to preserve the natural landscape and shall conduct operations to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity.

All equipment used shall be cleaned prior to use in the area to prevent transporting of invasive plant or noxious weed seeds.

- E. Determination:** Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
