- A. **Brief Description of Proposal:** Western Area Power Administration (Western) proposes to replace Structures 468, 470, and 483 on the Big Springs - Ogallala (BSG-OGT) 115-kV Transmission Line. Structure 468 is a wooden three-pole structure, and Structures 470 and 483 are wooden H-frame structures. The structures would be replaced in-kind, and in the same locations. One new landing pad would be constructed as part of the replacement of Structure 468. All work would be confined to Western's right-of-way (ROW) easement on private property near Brule, Nebraska. Existing access would be used, no new roads are proposed, and no road maintenance is necessary for access. The equipment utilized may include a crane, man-lift, backhoe, rubber-tired pressure digger/derrick, skid-steer loader, pole trailer, and line trucks.
- B. **Number and Title of the Categorical Exclusion Being Applied:** (See text in 10 CFR Part 1021, Subpart D.)

#### **B1.3. Routine Maintenance.**

**Routine maintenance activities** and custodial services for buildings, **structures**, rights-of-way, infrastructures (including, but not limited to, pathways, roads, and railroads), vehicles and equipment, and localized vegetation and pest control, during which operations may be suspended and resumed, provided that the activities would be conducted in a manner in accordance with applicable requirements. Custodial services are activities to preserve facility appearance, working conditions, and sanitation (such as cleaning, window washing, lawn mowing, trash collection, painting, and snow removal). Routine maintenance activities, corrective (that is, repair), preventive, and predictive, are required to maintain and preserve buildings, structures, infrastructures, and equipment in a condition suitable for a facility to be used for its designated purpose. Such maintenance may occur as a result of severe weather (such as hurricanes, floods, and tornados), wildfires, and other such events. **Routine maintenance may result in replacement to the extent that replacement is in-kind and is not a substantial upgrade or improvement. In-kind replacement includes installation of new components to replace outmoded components, provided that the replacement does not result in a significant change in the expected useful life, design capacity, or function of the facility.** Routine maintenance does not include replacement of a major component that significantly extends the originally intended useful life of a facility (for example, it does not include the replacement of a reactor vessel near the end of its useful life). Routine maintenance activities include, but are not limited to:

- (a) Repair or replacement of facility equipment, such as lathes, mills, pumps, and presses;
- (b) Door and window repair or replacement;
- (c) Wall, ceiling, or floor repair or replacement;
- (d) Reroofing;
- (e) Plumbing, electrical utility, lighting, and telephone service repair or replacement;
- (f) Routine replacement of high-efficiency particulate air filters;
- (g) Inspection and/or treatment of currently installed utility poles;
- (h) Repair of road embankments;
- (i) Repair or replacement of fire protection sprinkler systems;

- (j) Road and parking area resurfacing, including construction of temporary access to facilitate resurfacing, and scraping and grading of unpaved surfaces;
- (k) Erosion control and soil stabilization measures (such as reseeded, gabions, grading, and revegetation);
- (l) Surveillance and maintenance of surplus facilities in accordance with DOE Order 35.1, "Radioactive Waste Management," or its successor;
- (m) **Repair and maintenance of transmission facilities, such as replacement of conductors of the same nominal voltage, poles, circuit breakers, transformers, capacitors, crossarms, insulators, and downed powerlines, in accordance, where appropriate, with 40 CFR part 761 ("Polychlorinated Biphenyls Manufacturing, Processing, Distribution in Commerce, and Use Prohibitions") or its successor;**
- (n) Routine testing and calibration of facility components, subsystems, or portable equipment (such as control valves, in-core monitoring devices, transformers, capacitors, monitoring wells, lysimeters, weather stations, and flumes);
- (o) Routine decontamination of the surfaces of equipment, rooms, hot cells, or other interior surfaces of buildings (by such activities as wiping with rags, using strippable latex, and minor vacuuming), and removal of contaminated intact equipment and other materials (not including spent nuclear fuel or special nuclear material in nuclear reactors); and
- (p) **Removal of debris.**

well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

**D. Special Stipulations Pertaining to the Proposal:**

If the scope of work of this project changes, Western's Environmental Division must be contacted for additional environmental review.

This Categorical Exclusion expires on December 31, 2016. If all project work has not been completed by the expiration date, or if need for a project extension is anticipated, Western's Environmental Division must be contacted for an updated environmental review.

**To comply with the Migratory Bird Treaty Act, maintenance work should be scheduled outside the March 1 to July 31 general nesting period.** If the maintenance work is to be done during this period, contact Western's Environmental Division so that they may arrange for a pedestrian survey to be conducted in advance of the maintenance crews to identify active nests that are to be avoided.

If any cultural materials are discovered during construction, work in the area shall halt immediately, Western's Regional Preservation Officer shall be contacted, and the material be evaluated by an archaeologist or historian meeting the Secretary of the Interior's Professional Qualification Standards (48 FR 22716, Sept. 1983).

**A cultural resources monitor must be present during construction at structures 470 and 483.** A monitor will mark this area for avoidance prior to construction. Please notify Western's Environmental Division at least two weeks prior to construction so that the monitor can be present when needed.

Limit movement of construction crews and equipment within the maintenance corridor, including access routes, to minimize damage within the ROW corridor. Maintenance activities shall be conducted to minimize scarring, or defacing of the natural surroundings in the vicinity of the work. Except where terrain damage results, terrain and vegetation shall be preserved and protected from damage by maintenance crew operations and equipment.

To minimize impacts to the environment and prevent damage to access roads, operation of off-road equipment will not be permitted during periods of heavy rains, when soils are wet, or when excessive soil damage may occur due to unsuitable operating conditions. No construction or routine maintenance activities shall be performed during periods when the soil is too wet to adequately support construction equipment. If equipment creates ruts in excess of six inches deep, the soil shall be deemed too wet to adequately support construction equipment.

Western would implement standard best management practices for erosion, seeding, and noxious weed control. Western's clean vehicle policy will apply, and all equipment used will be washed and cleaned prior to use in the area to prevent transporting of invasive plant or noxious weed seeds.

If the used poles are sold or donated, the Project Manager will ensure the recipients have read and signed Western's consumer information sheet for treated wood poles and cross-arms.

- E. **Determination:** Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
