Proposed Action Title: GridBright, Inc. - A Standards-Based Intelligent Repository for Collaborative Grid Model Management

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Alamo, CA and Minneapolis, MN

Proposed Action Description:

Funding will support development and testing of a power systems model repository based on state-of-the-art open source software. The models in this repository will be used to facilitate testing and adoption of new grid optimization and control algorithms, and the repository will use field-proven open source software and be made publicly available. Key features of the repository include semantic model-based search capability to support the research community, faster model upload and download times, and the ability to support thousands of users. If successful, this project could provide a means of comprehensively evaluating emerging electric grid operation optimization algorithms that have the potential to substantially reduce the costs of integrating variable renewable generation technologies into the electric power system in the United States.

The proposed project activities under this award are limited exclusively to intellectual, academic, or analytical activities. The project team will not conduct physical experiments, prototype fabrication, demonstration projects, or similar activities under this award. Project activities will take place in GridBright, Inc.'s and Utility Integration Solutions, LLC's office facilities located in Alamo, CA and Minneapolis, MN, respectively.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
