Proposed Action Title: Iowa State University - Low Cost, Safe, and Efficient All Solid State Sodium Batteries for Grid-Scale Energy Storage and Other Applications

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop all-solid-state sodium batteries designed to have a high energy content and be easily recycled. Specifically, the project team will: 1) develop new sodium-free anodes; (2) develop a new class of solid state electrolytes; (3) develop low-cost cathode materials; (4) develop a multi-scale model to simulate battery performance; and (5) integrate the anode, cathode, and other components into proof-of-concept cells. If successful, the battery will achieve a 20% improvement in energy density over state-of-the-art lithium-ion cells.

Project activities will be conducted at existing facilities that are designed for the applicable activities, and will be conducted in accordance with applicable Federal, State, and local safety and environmental requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
