Proposed Action Title: Tibbar Plasma Technologies, LLC - Plasma-based AC-DC Transformer for HVDC Transmission

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Los Alamos, NM

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop an AC-DC transformer that uses no capacitors or semiconductor switches and rely on helical coils that induce output current and voltage through electrodes at the ends of plasma. Specifically, the project team will: (1) adapt, develop, and use 3-D Magnetohydrodynamics code to design plasma transformers and (2) build and develop the pulsed prototype transformer. If successful, the transformer may be half the cost and yield power densities 10x higher than state-of-the-art transformers, potentially providing a new enabling technology for High Voltage Direct Current transmission.

Project activities will be conducted at existing facilities that are designed for the applicable activities, and will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local safety and environmental requirements. Minor modifications will be made to existing facilities to accommodate the proposed work, including the installation of a new 480-volt three phase AC transformer and associated utilities. Prime Recipient Tibbar Plasma Technologies is required, under the terms of its ARPA-E Cooperative Agreement, to secure all necessary permits prior to installing the transformer and to provide ARPA-E with written assurances of acquiring such permits prior to installation. There will be no ground disturbing activities.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
