Proposed Action Title: Eaton Corporation - Synthetic Cloud-Based Regulation Reserve Distribution Management System

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Eden Prairie and Plymouth, MN; Menomonee Falls, WI; Lexington, MA; Ithaca, NY; San Ramon and Livermore, CA

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop a cloud-computing solution for synthetic regulating reserve services to the power grid. Specifically, the project team will: (1) develop water heater, electric vehicle, building thermodynamic, and residential scale battery modeling; (2) develop synthetic regulation reserves controls; (3) develop cloud software architecture and platform; (4) conduct small, medium, and large scale computer-based simulation testing and software validation; and (5) conduct Hardware-in-the-Loop validation at existing facilities. If successful, the project would significantly reduce computational and communication complexity, thereby enabling large-scale coordinated control of a vast number of distributed energy resources and flexible loads. No modifications will be made to existing facilities to accommodate the proposed work.

Project activities will be conducted at existing facilities that are designed for the applicable activities at Eaton Corporation (Eden Prairie, MN; Menomonee Falls, WI; Plymouth, MN); MIT Lincoln Laboratory (Lexington, MA); Cornell Laboratory (Ithaca, NY); Pacific Gas & Electric (San Ramon, CA); Argonne National Laboratory (Argonne, IL); and Lawrence Livermore National Laboratory (Livermore, CA). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
