Proposed Action Title: GE Global Research - Synthetic Reserves from Aggregated Distributed Flexible Resources

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Niskayuna, Schenectady, and New York, NY; Boulder, CO; Berkeley, Westminster, and Sacramento, CA

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop forecasting tools and algorithms to efficiently deploy renewable energy generation to the grid. In particular, the team would develop a technology that aggregates flexible loads and distributed energy resources (DERs) to provide synthetic reserve services to the grid while maintaining customer quality of service. Specifically, the project team will: (1) collect and analyze load data to develop load models; (2) develop a forecasting tool to estimate the reserve potential of aggregate loads and DERs on a day-ahead and short-term basis; (3) develop associated algorithms; and (4) validate developed algorithms through hardware-in-the-loop (HiL) testing and simulation testing. Testing will occur at existing laboratory and commercial or industrial customer locations.

Project activities will be conducted at existing facilities that are designed for the applicable activities at GE Global Research (Niskayuna, NY); GE Energy Consulting (Schenectady, NY and Boulder, CO); Lawrence Berkeley National Laboratory (Berkeley, CA); Enbala Power Networks (New York, NY); Southern California Edison (Westminster, CA); Consolidated Edison, Inc. (New York, NY), and Sacramento Municipal Utility District (Sacramento, CA). Project tasks will be conducted in accordance with with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.


The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
