Proposed Action Title: Northeastern University -- A New Class of Soft-Switching Capacitive-Link Universal Converters for Photovoltaic Application

Program or Field Office: Advanced Research Projects Agency - Energy (ARPA-E)

## Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop single-stage, universal power converters using Silicon (Si) Insulated-Gate Bipolar Transistors and Silicon Carbide Metal Oxide Semiconductor Field-Effect Transistors. Specifically, the project team will: (1) finalize the design of a Si-based prototype to meet efficiency, weight, cost, and lifetime goals and (2) fabricate and test the Si-based prototype. If successful, the project will increase the converters' power density, lifetime, and efficiency and significantly reduce the life-cycle costs associated with power converters.

Project activities will be conducted at an existing facility designed for the applicable activities at Northeastern University (Boston, MA). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
