Proposed Action Title: Rattlesnake-Del Bac: Structure 6/6 Replacement

Program or Field Office: Western Area Power Administration, Desert Southwest Region

Location(s) (City/County/State): 16 miles west/northwest of Tucson - Pima County, Arizona

Proposed Action Description:

Western Area Power Administration (WAPA) is proposing to replace the pole and insulators on Structure 6/6 of the Rattlesnake (RSK) - Del Bac (DLB) segment. Existing access to the project area is sufficient (junction of Orange Grove Rd and Avra Rd); there would be no ground disturbance required. Work would be completed using a line truck, bucket truck, and haul truck. Work would be begin on November 1, 2017 and take no more than a couple days to complete.

Special Conditions:

1) WAPA's maintenance staff should implement their annual environmental awareness training, be mindful to stay on existing access roads and disturbed areas, and avoid burrows that may be inhabited by tortoises and burrowing owls.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

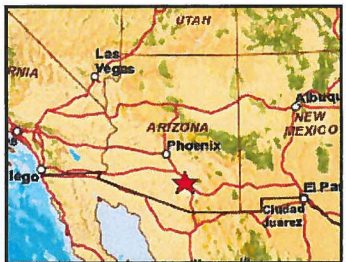
