Proposed Action Title: Switched Source, LLC- Transformer-less Modular Unified Power Flow Controller

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Bolingbrook, IL; Champaign, IL; West Lafayette, IN; East Lansing, Michigan

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to resolve key technical issues and hit performance and cost metrics verified through a field trial for its UPFC (unified power flow controller), a unique power electronics device for use on the grid. Specifically, the project team will: (1) verify the design targets with the utilities; (2) review the existing design for performance limitations and scalability; (3) conduct modeling and simulation based on new metrics; (4) test the fully assembled UPFC at a medium voltage laboratory; and (5) install the UPFC at the Ameren field test site for final verification of the performance. If successful, the UPFC could address reliability issues associated with old infrastructure and provide a stronger network so that more distributed renewable energy resources can connect to the grid.

Project tasks will be conducted on a small-scale basis in dedicated laboratory, testing, and fabrication facilities at G&W Electric (Bolingbrook, IL); Ameren, IL (Champaign, IL); PC Krause and Associates (West Lafayette, IN); and Michigan State University (East Lansing, MI). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. Minor modifications will be made to the existing facilities to accommodate the proposed work. Switched Source is required, under the terms of its ARPA-E Cooperative Agreement, to secure all necessary permits or approvals prior to conducting field testing.


To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
