Proposed Action or Project Description:

MOX-Termination has determined that portable building 252 (aka SRS-PB-01072) is now excess. The material that was previously stored in the building has been relocated. The building will be demolished by MOX-T operations. Building number 252 (aka SRS-PB-01072) is not connected to electrical service or any other cable or conduit. The portable building is located in a laydown yard located in M-Area at SRS.

- There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal would not threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of Appendix B to Subpart D of 10 CFR Part 1021; involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements.
