AMENDED NEPA DETERMINATION: (See attached original Determination, dated March 26, 2019)

This Amended Determination follows the approval of changes to the project team, additional funds, and modifications to the milestones to support the project team's small-scale, research and development activities to expand on the transformer improvement work being developed at Sandia National Laboratories. Specifically, the project team will continue its work to develop (1) an advanced magnetic core material, (2) an oil additive to improve thermal performance, and (3) an oil additive to restore degraded kraft paper insulation. If successful, this project will increase electrical efficiency and enable significant reductions in both size and weight of transformers (decreasing the size of a 5 kVA transformer by 20% over a baseline device) while increasing their resiliency to electromagnetic pulse and geomagnetic disturbance events.

Project activities will be conducted at existing facilities at Purdue University (West Lafayette, IN); Sandia National Laboratories (Albuquerque, NM); and Continuous Solutions (Portland, OR) designed for the applicable activities. Project tasks continue to fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the project. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
