Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the South Dakota Energy Management Office to provide a grant to the Black Hills State University (BHSU) in Spearfish, SD to install a 137 kW roof-mount solar array. The solar array would be installed on two areas of the David B. Miller Yellow Jacket Student Union roof and an area of roof over the Jonas Skywalk. The solar array would supply electricity to the Student Union. Any excess power would be added to the BHSU power grid and used to power other buildings on campus.

The proposed array would consist of 380 panels and 3 inverters along with associated electrical wiring, conduit, racks, and ballasts. No structural improvements to either roof would be required. Additionally, no ground disturbance would be required. The PV panels would not be visible from the public right-of-way.

The state of South Dakota must adhere to the restrictions of their DOE executed Historic Preservation Programmatic Agreement with their State Historic Preservation Office for the proposed activities. Any changes to the project activities or locations are subject to additional NEPA review by DOE and are not authorized for Federal funding unless and until the Contracting Officer provides written authorization on those additions or modifications.
