**Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:**

Description:

**A9 Information gathering, analysis, and dissemination** Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Spirit AeroSystems, Inc. to develop artificial intelligence/machine learning (AI/ML) software for use in inspection evaluations in the aerospace sector. The software would be designed to evaluate ultrasonic signals used in non-destructive inspections (NDI) of aerospace structures, especially those containing composite materials.

Proposed project activities would consist of data analysis, computer modeling, software development, and software validation testing. Both representative data and actual production data (NDI data of manufactured aircraft) would be used for software validation testing. Spirit AeroSystems would coordinate all project activities and provide production data for use in software development and testing. Project partners Argonne National Laboratory and Texas Research Institute would assist with data analysis, computer modeling, software development, and software validation testing. Project work would be limited to computer-based research. No physical experiments or field testing would be performed as part of the project.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
