**Proposed Action Title: West Portal-Stillwater Tap 69-kV Transmission Line Post-Fire
Emergency Power Restoration**

Location: Grand County, Colorado

Project Number: 2021-009

Expiration Date: June 30, 2021

A. PROPOSED ACTION DESCRIPTION:

Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), conducted emergency power restoration activities on the West Portal-Stillwater Tap (WPL-STX) 69-kV Transmission Line in Grand County, Colorado. This emergency power restoration was completed between Structures 3/3 and 5/3 in October and November 2020, following damage from the East Troublesome Fire. Restoration activities included clearing debris and chipping burned trees in the right-of-way (ROW), clearing snow for an off-ROW staging area south of Structures 4/7 and 4/8, installation of a temporary access road to Structure 5/3, off-ROW removal of debris and travel with heavy equipment north of Structures 4/5 to 4/7, partial replacement of Structure 3/4, and full replacement of Structures 4/4, 4/5, 4/8, 4/9, 5/2, and 5/3. Structure replacement activities included removal of the damaged structures, re-auguring the existing structure holes or auguring new structure holes, installation of the new wood structures, backfilling the structure holes, and installation of new hardware. The new transmission structures have minor structural updates to meet current WAPA design standards but are visually similar to the original structures. Equipment used for this project included bucket trucks, tracked auger and crane trucks, skid-steer loaders, chainsaws, tracked tree chipper, excavator, utility trucks, pole trailers, and equipment trailers. Work occurred within and outside of WAPA's right-of-way (ROW) on private lands.

B. STIPULATIONS PERTAINING TO PROPOSAL:

This Categorical Exclusion (CX) covers emergency work that has already been completed. No further work is authorized under this CX. If additional work is required, RMR's Environment Department must be contacted to determine whether additional environmental review is required.

D. REGULATORY REQUIREMENTS 10 CFR 1021.410 (b): (See full text in regulation)

The proposed action fits within a class of actions that is listed in Appendix A or B of 10 CFR 1021.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been improperly segmented, and the proposal is not connected to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.
