Proposed Action Title: InventWood LLC - Wood Honeycombs for Lightweight, Energy-Efficient Structural Applications

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): College Park, Maryland; Madison, WI

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to produce lightweight corrugated wood panels employing a cell-wall engineering process that results in 3D structures with the goal of outstanding mechanical strength as compared to natural wood (and similar to honeycombed aluminum). Specifically, the project team will (1) produce five panels, strength tested along both axes showing a strength compression comparable to Aluminum honeycomb and perform a life cycle assessment to evaluate CO2 impact; and (2) assemble ten panels with a significant compressive strength and meeting relevant standards metrics for flammability, water resistance, and strength testing along both axes for building panel applications. If successful, the team will demonstrate their 3D wood corrugated honeycomb structures can match the current state of the art metal alternatives in terms of mechanical strength, while being 1/3 as dense, 1/14th the cost, and 90% less emissions intensive.

Project activities will be conducted at existing facilities: InventWood's laboratory and University of Maryland lab (in College Park, Maryland) and at the USDA Forest Products Laboratory (Madison, WI) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
