Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

- A9 Information gathering, analysis, and dissemination** Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)
- B3.1 Site characterization and environmental monitoring** Site characterization and environmental monitoring (including, but not limited to, siting, construction, modification, operation, and dismantlement and removal or otherwise proper closure (such as of a well) of characterization and monitoring devices, and siting, construction, and associated operation of a small-scale laboratory building or renovation of a room in an existing building for sample analysis). Such activities would be designed in conformance with applicable requirements and use best management practices to limit the potential effects of any resultant ground disturbance. Covered activities include, but are not limited to, site characterization and environmental monitoring under CERCLA and RCRA. (This class of actions excludes activities in aquatic environments. See B3.16 of this appendix for such activities.) Specific activities include, but are not limited to: (a) Geological, geophysical (such as gravity, magnetic, electrical, seismic, radar, and temperature gradient), geochemical, and engineering surveys and mapping, and the establishment of survey marks. Seismic techniques would not include large-scale reflection or refraction testing; (b) Installation and operation of field instruments (such as stream-gauging stations or flow-measuring devices, telemetry systems, geochemical monitoring tools, and geophysical exploration tools); (c) Drilling of wells for sampling or monitoring of groundwater or the vadose (unsaturated) zone, well logging, and installation of water-level recording devices in wells; (d) Aquifer and underground reservoir response testing; (e) Installation and operation of ambient air monitoring equipment; (f) Sampling and characterization of water, soil, rock, or contaminants (such as drilling using truck- or mobile-scale equipment, and modification, use, and plugging of boreholes); (g) Sampling and characterization of water effluents, air emissions, or solid waste streams; (h) Installation and operation of meteorological towers and associated activities (such as assessment of potential wind energy resources); (i) Sampling of flora or fauna; and (j) Archeological, historic, and cultural resource identification in compliance with 36 CFR part 800 and 43 CFR part 7.

Rationale for determination:

The U.S. Department of Energy (DOE) has an active financial assistance agreement with Sunvapor, Inc. to design, develop, and demonstrate a novel steam accumulator for solar industrial steam applications that would enable the cost-effective integration of solar steam with a typical manufacturing process. The project is being conducted over three budget periods (BP) with a go/no-go decision point in between each budget period. DOE reviewed and categorically excluded Budget Period 1 from further NEPA review (ND GFO-0008993-001). And, DOE authorized the expenditure of federal funding for BP1. DOE is now proposing to authorize the expenditure of federal funds for BP2. This NEPA determination applies to BP2.

Budget Period 2 activities would include design and engineering study of the proposed energy storage system (which would include a geotechnical and topographic survey of the proposed site), requesting an obtaining bids from contractors, permitting, NEPA review, and development of contract documents for the construction and operation of the proposed energy storage system. Engineering and design, and planning activities would take place at

Sunvapor's offices in Pasadena, CA. Geotechnical and topographical studies be conducted at Imperial Western Products in Coachella, CA, the proposed industrial host site. The Imperial Western Products site is an existing industrial operation, any ground disturbing activities associated with the geotechnical or topographical studies would occur in a previously disturbed and currently developed setting.

DOE does not anticipate adverse impacts to any resources of concern to result from BP2 activities. Further, the completion of proposed BP2 activities will result in the information necessary for DOE to conduct a meaningful review of the environmental impacts associated with the BP3 activities (construction and operation of the energy storage system).

This NEPA Determination applies to BP2 activities. Additional DOE NEPA review is required prior to authorizing funding for BP3 activities, should the project receive approval from the Solar Energy Technologies Office to move forward into BP3.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
