**Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:**

**CX, EA, EIS APPENDIX AND NUMBER:**

Description:

**A9 Information gathering, analysis, and dissemination** Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the New York State Energy Research and Development Authority (NYSERDA) to form a not-for-profit 501(c)(3) entity, the "National Offshore Wind Research and Development Consortium" which would be led by NYSERDA, along with key industry stakeholders and research institutions. The Consortium would finance research initiatives seeking to address the technical barriers faced by offshore wind developers, original equipment manufacturers (OEMs) and supply chain partners, with the goal of reducing the Levelized Cost of Electricity (LCOE) for U.S. offshore wind plants and increasing opportunities for U.S. manufacturing.

The proposed project is divided into four (4) Budget Periods (BPs). DOE previously completed NEPA reviews for BP1, 2 and 3 (GFO-0009380-001 CX A1, A9 and A13, 10/09/2018; GFO-0009380-002 CX A1, A9 and A13, 01/13/2020; GFO-0009380-019 CX A1, A9 and A13, 12/02/2020). In addition, DOE completed NEPA reviews for 16 subawards made by the consortium under Task 19 (GFO-0009380-003 to 018, various CX determinations and dates) as well as awards under an Annual Operating Plan to the National Renewable Energy Laboratory. This NEPA review is for a sub award proposed to be made under Task 27 to CODAR Ocean Systems, Ltd.

Task 27 in BP3 involves reviewing applications received in response to the solicitation released in Task 26, and then choosing specific projects which would receive a sub award. While NYSERDA is allowed under the previous NEPA determination to proceed with choosing projects under Task 27, all projects chosen for sub award are subject to additional NEPA analysis prior to NYSERDA contracting for the sub award and prior to any work being completed on the sub award.

Under the proposed sub-award CODAR Ocean Sensors, Ltd., would perform activities including new computer modeling, data-collection, analysis, and feasibility studies regarding the application of high-frequency radar (HFR) to determine how ocean surface current data is impacted by wind-turbine interference (WTI). Coastal ocean dynamics applications radar (CODAR) is a type of portable, land-based, High Frequency (HF) radar that allows measuring and mapping ocean surface currents. Ocean surface current and wave measurement data would be collected from an existing radar station and would be used to develop techniques to reduce data errors caused by wind turbine interference. CODAR Ocean Sensors, Ltd., would install SeaSonde Elliptical Processing Suite software to existing computers to reduce gaps and errors in the data caused by WTI. The proposed project would be limited to information gathering and data analysis.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

**FOR CATEGORICAL EXCLUSION DETERMINATIONS**

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

A portion of the proposed action is categorically excluded from further NEPA review. The NEPA Provision identifies Topic Areas, Budget Periods, tasks, and/or subtasks that are subject to additional NEPA review.
