

CATEGORICAL EXCLUSION (CX) DETERMINATION

Southwestern Western Power Administration proposes to modify and/or construct several Oklahoma and Arkansas communication tower facilities as part of the Spectrum Relocation Project. Communication tower facility modifications and construction activities include new tower construction, various levels of existing tower removals and/or replacements and, in some instances, facility site expansion or land disposition.

NUMBERS AND TITLES OF THE CATEGORICAL EXCLUSIONS BEING APPLIED:

10 CFR 1021, Appendix B to Subpart D. 1-1-97 Edition, Part B1,19- Siting, construction and operation of microwave and radio communication towers and associated facilities, if the towers and associated facilities would not be in an area of great visual value.

REGULATORY REQUIREMENTS IN 10 CFR 1021.410(B):

- (1) The proposed action fits within a class of actions that is listed in Appendix A & B to Subpart D. For classes of action listed in Appendix A or B, the following conditions are integral elements, i.e., to fit within a class, the proposal must not:
 - Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, (a.) safety, and health, including DOE and/or Executive Orders;
 - Require siting, construction, or major expansion of waste storage, disposal, recovery, or treatment facilities, but may include such categorically excluded facilities;
 - Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that pre-exist in the environment such that there would be uncontrolled or unpermitted releases: or
 - Adversely affect environmentally sensitive resources (including but not limited to those listed in paragraph B. (4)).
- (2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal; and
- (3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

DETERMINATION: Based on review of information conveyed to me and/or in my possession (or attached) concerning the proposed action, as Southwestern Power Administration's NEPA Compliance Officer (as authorized under DOE Order 451.1A). I believe that the proposed action fits within the specified class of action, the other regulatory requirements set forth above are met, and therefore the proposed action is hereby categorically excluded from further NEPA review:
