Project Title: Replace Dilution Inhibited Water Facility Caustic Tank

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken/South Carolina

Proposed Action or Project Description:

The F-Area Tank Farm (FTF) Dilution Inhibited Water Facility (DIWF) caustic storage tank is leaking and approaching the end of its service life. Facility management wants to redesign to use palletized storage containers/totes connected to the caustic metering pump suction line via hose versus installing a new tank. In making this change it must be ensured that the existing metering pumps will maintain enough Net Positive Suction Head (NPSH) to prevent cavitation. If there is any issue with the metering pumps maintaining NPSH, provide new pumps. Provide an accumulation stand pipe as needed to prevent cavitation.

- There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or § 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

This proposal would not threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of Appendix B to Subpart D of 10 CFR Part 1021; involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements.

Based on my review of information conveyed to me and in my possession (or attached) concerning the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
