Rationale for determination:

The U.S. Department of Energy is proposing to provide funding to Toshiba International Corporation (Toshiba) in support of a research and development project to design, develop, assemble, and test a medium voltage manufacturing-ready, utility-scale solar plus storage inverter prototype. This project would be complete over two Budget Periods (BPs).

Project activities include design, development, assembly and testing of modular prototypes and would take place at an operational research lab at the University of Texas at Austin and Toshiba International Corporation's manufacturing facility in Houston, Texas. All work would be conducted in existing, purpose-built facilities. No new permits are required to complete the proposed project activities. DOE does not anticipate adverse impacts to sensitive resources as a result of this project.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in

Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
